The Sargent County Board of Commissioners met at 10:00 a.m., following the county park board meeting, with the following members present: Jerry Waswick, David Jacobson, Sherry Hosford, Mike Walstead, and Bill Anderson. Also present was Lyle Bopp, State's Attorney; Donna Eklund, county resident; Jason Arth, county resident; Tibby Hinderlie, The Sargent County Teller; and Pam Maloney, Sargent County Auditor.

Austin McLaen & Jeff Anderson, representing SCB Public Finance, arrived at the meeting. They provided information on refinancing the lease-purchase agreements on the county's three John Deere motor graders that are currently financed with John Deere. Each motor grader was individually compared and new balloon payments were calculated for each one based on refinancing with SCB Public Finance. The total cost savings to have the existing lease-purchase agreements on the equipment financed by SCB Public Finance will be approximately \$21,074 provided that the warranty was pre-paid at the time the equipment was acquired and that there is no penalty for pre-payment of the current contracts. Lyle Bopp, State's Attorney, was asked by the Commission to review the current contracts concerning the questions about warranty, pre-payment and any other matters which may be of concern if the lease-purchase agreements are financed elsewhere. Mr. McLaen was asked to bring a quote to the November 1 meeting to refinance all three machines with a four year lease.

Jayne Pfau, Assistant State's Attorney, arrived at the meeting.

Approve Gaming Permit No. 2016-02 to the DeVern Kurtz Cancer Benefit for a raffle on December 3, 2016 at the Stirum Hall, Stirum, ND. After consulting with the States Attorney, reviewing the permit application and the circumstances requiring the benefit, the county commission found the DeVern Kurtz Benefit to be a public spirited organization as contemplated by state law, and entitled to a charitable gaming permit. (Anderson/Walstead, unanimous)

Kent Thoreson & Damon DeVillers, Interstate Engineering; LeeAnn Even, Milnor City Attorney; Terry Dusek & Monty Haugen, Milnor City Council; Kent Sundseth, U.S. Fish and Wildlife Service F&WS); & Sandra Hanson, Tax Director/911 Coordinator/Emergency Manager; arrived at the meeting. Discussion held regarding the proposed creation of the Storm Lake Dam Federal Maintenance District. Mr. Sundseth stated that the U.S. Fish & Wildlife Service does own the structure and that there has not been any divestiture of ownership or control of the dam. The U. S. Government, through the Fish & Wildlife Service has not relinquished authority over the property and does maintain the water interest in Storm Lake at 92'. The F&WS sees no need for improvements on the structure at this time. States Attorney Bopp advised that the last document of record in the County Recorder's Office concerning this property is the deed conveying the real estate to the United States of America, and that there are no documents indicating an intent to divest ownership or to cease to maintain and operate the structure. Motion to refer this issue back to the Sargent County Water Resource Board for reconsideration of the proposed Storm Lake Dam Maintenance District due to the information received concerning the ownership, maintenance and operation of the dam structure. (Anderson/Walstead). Roll Call Vote: Yes – Jacobson, Walstead, Anderson and Waswick. No – Hosford. Motion carried.

Motion to introduce the resolution declaring the necessity to create the Storm Lake Dam Maintenance District. (Hosford, died for lack of second) Commissioner Hosford stated that there will be a water board meeting on Thursday, October 20 starting at 8:00 a.m. and asked the commissioners to attend.

Approve minutes of the October 4, 2016, commission meeting as corrected. (Hosford/Jacobson, unanimous)

Approve Gaming Permit No. 2016-01 to the Tewaukon Rod & Gun Club for a raffle on January 13, 2017 at the Geneseo Hall, Geneseo, ND. (Hosford/Anderson, unanimous)

Commissioner Anderson offered the following resolution and moved its adoption, seconded by Commissioner Walstead:

WHEREAS, the Lake Agassiz Regional Council strives to assist in the planning and economic development of Sargent County and Lake Agassiz Regional Council as a whole, and

WHEREAS, planning and economic development are among the objectives of the Board of Commissioners of Sargent County,

NOW THEREFORE BE IT RESOLVED, that Sargent County approves and supports the planning and economic development program and budget of the Lake Agassiz Regional Council during the Fiscal year 2017 in the amount of \$1,500.00.

Voting aye: Waswick, Hosford, Anderson, Jacobson and Walstead. Voting nay: None. Resolution was adopted.

Merrill Engquist, Road Supervisor; and, Damon DeVillers, Interstate Engineering; arrived at the meeting. Mr. Engquist reported that the culvert in the field approach north of Brampton will be repaired on Thursday, October 20; Crandall Construction has commenced work on the Alkali Lake Access Road project; the road crew has been working on chipping County Road #1; and that the road crew will be doing more slope work on County Road #14 to get those slopes that are not at 4:1 to that There was discussion regarding the current placement of speed limit and "Watch for standard. Children" signs near a farm site south of Geneseo. Mr. Engquist will look over the area and move the signs to help slow down traffic past the farm site. There was discussion also, regarding a section line and private drive north of Cayuga off County Road #12, that has a street sign at the corner and, as a result, the farmstead gets lots of traffic. Mr. Engquist will leave the street sign, but install "Dead End" signs at the intersection. Mr. Engquist informed the board that he would be applying mag chloride to several spots that had not been treated when the rest of the county had been done due to road projects and/or graveling yet to be done. It was decided to apply the mag chloride to these areas to control dust through the fall and winter months. Mr. DeVillers reminded the commission to prioritize future road projects for ND DOT.

The commission reviewed an "Application for Drainage Work Within County Road Right-Of-Way" for Heimbuch Farms to install a drain tile lift station along the north side of the NE1/4 of 18-129-57 in Brampton Township. The lift station will be installed in the field and then discharge into the south side ditch on County Road #5. Motion to approve the application pending approval of the project from the Sargent County Water Resource Board. (Walstead/Anderson, unanimous)

Commissioner Waswick reported that he and Alison Toepke, Treasurer/Recorder/Clerk of Court, have discussed some ideas for the court facilities improvement grant. Lyle Bopp, State's Attorney, also suggested that an ITV system might be installed, as one of the judges had requested one.
