Orville Nelson, representing the Sargent County Historical Society, arrived at the meeting. He provided a financial statement to the board members and reported on museum activities for 2015. He invited the commission to hold the 5-County Meeting at the museum the next time that it is Sargent County's turn to host. The commission thanked Mr. Nelson for coming in & for the wonderful work that has been done at the Sargent County Museum.

Merrill Engquist, Road Supervisor; and, Jesse Sedler, Interstate Engineering; arrived at the meeting. Mr. Engquist reported that he has checked with Berube's and will check with Lillegard's regarding a Bobcat trade-in program that had been offered in the past by Jacobson Implement. He will also check with Titan and RDO regarding a tractor lease program. The road crew has been working on the slopes on County Road #14 south of #5, and will be installing a culvert to replace the "Edwin Anderson Bridge" at 101st ST SE and 148th AV SE in Marboe Township.

Motion to authorize the chairman and auditor to execute and sign the lease documents with SC Public Finance for the three motor graders now being leased through John Deere. (Anderson/Walstead, unanimous)

Some discussion was held regarding the new overtime regulations released by the U.S. Department of Labor. The auditor was instructed to seek out additional information concerning the applicability of the new regulations to salaried County employees.
