The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Mike Walstead, David L Jacobson, Jerry Waswick, Bill Anderson and Steve Wyum. Absent: None. Paige Cary, the Sargent County Teller was also present.

Approve minutes of December 6, 2011 as corrected. (Wyum/Walstead, unanimous) Approve minutes of the Special Meeting convened on December 14, recessed, and adjourned on December 19, 2011, as corrected. (Walstead/Wyum, unanimous) Board members also received a copy of the November financial statement.

Approve beer and liquor license for 2012 to: Merril and Gloria Decker, North Forty, Inc., DeLamere, ND. (Wyum/Walstead, unanimous)

Approve Sunday Permit to Sell Alcoholic Beverages at North Forty, Inc., DeLamere, ND for twelve months. (Jacobson/Waswick, unanimous)

Authorize Jerry Waswick, Courthouse Commissioner to sign documents and submit the application requesting grant funds for court facilities improvements in the Sargent County Courthouse to include cameras for the courthouse entryways and walk-thru and handheld metal detectors. (Jacobson/Wyum, unanimous)

Lyle Bopp, States Attorney arrived at the meeting at 9:40.

Discussed December 6, 2011 motion to release contingency funds equivalent to six months of a step increase to all employees. The County Auditor was seeking clarification as to whether seasonal employees were to be included in the contingency fund disbursement. The question was whether seasonal employees are considered employees as of the date of the motion during the "off" season, when they may be drawing unemployment compensation or employed elsewhere. Motion to exclude seasonal employees and county commissioners from contingency fund distribution. (Jacobson/Waswick.) States Attorney Bopp advised that the County's Personnel Manual contains a classification defining "seasonal employees" who are employed on a regular basis, from season to season. Motion to amend the original motion to include all seasonal and regular part-time employees on a pro-rata basis equivalent to one-half of their time based on their employment during the year. (Wyum/Walstead. Amendment approved and Motion as Amended carried)

Boyd Brummond and Charles Anderson, Weber Township Board members, Richard Ruch, Brampton Township, Sparky Engquist, Road Supervisor and Sandy Hanson, Tax Director/Emergency Manager /911 Coordinator arrived at the meeting to further discuss the washed out multi-plate culvert at the former bridge site on the Wild Rice River located between Section 31 of Rutland Township and Section 6 of Weber Township. Weber Township proposes to abandon the one mile of roadway located on 96th Street, thereby allowing the county to abandon the bridge. The Weber Township supervisors would like to accompany the engineer to the site, and make recommendations on how to build up the alternative roads to allow two families a route to enter and exit their farmsteads. The township requests that a proper allowance be made available to make this new roadway a viable and dependable route for local traffic. Chairman Anderson commented that the county would just a soon eliminate this little used bridge site and use the funds to improve more heavily used routes that cross the Wild Rice, as allowed by FEMA, so, if the township is comfortable without that bridge, then the county commission is comfortable without the bridge, as well, but wants to be certain that there is reasonable and dependable access for the people who live on those roadways. Both the county and the township have to work with FEMA to make this project happen, and more information will be requested on the FEMA appropriation and hazard mitigation funding. Chairman Anderson encouraged the township board members to adopt design standards for Weber Township roadways, if the Township has not already done so.

Sparky Engquist, Road Supervisor and Damon DeVillers met with the Board to discuss road projects completed and ongoing in the county.

Mark Gainor, Milnor Airport Authority met with the commission to provide photos of the new airplane hangar built at the Milnor Airport. The hangar was built, in part, with grant funding from the North Dakota Aeronautics Commission. The commissioners commended Mr. Gainor and the other members of the Milnor Airport Authority for their work to maintain and improve a valued community asset. Motion to authorize the chairman to execute the Airport Authority Contracts with both Milnor Airport and the Roger Melroe Field located in Gwinner. Both contracts are for a minimum of three years, and will renew automatically thereafter unless terminated by one of the parties. (Waswick/Jacobson, unanimous)

Sandy Hanson met to discuss a contract dispute between TON Construction and a sub-contractor, Jerry Sapa, concerning a bill for work on the pavilion built at Silver Lake. the County Park Board had withheld payment of \$1000 of the contract price, pending completion of all work on the project by the contractor. Sandy reported that only the vinyl baseboards trim remains to be installed, and it is best to wait until next spring to do that to allow the treated wood a chance to dry out. According to the final billing submitted by TON Construction, only \$100 was allowed by TON for the base board installation. Sub-contractor Jerry Sapa, who was contracted by TON Construction to finish the interior work, had talked to Sandy earlier and requested that only \$100 be withheld pending completion of the work in the spring. Pursuant to authority delegated by the Park Board to the County Commission to act on Park District bills during the winter months, when the Park Board does not hold regular meetings. Motion to withhold \$250 until the project is completed and approve payment of \$850 to TON Construction. (Wyum/Waswick. Motion carried)

Sandy Hanson informed the Board that Vanguard Appraisals will be coming to Sargent County in January for training to county employees on the residential appraisal process. She will be working with the commissioners with plans to present the new appraisal plan to the public in late February/early March. Sandy is waiting for three townships to turn in their soils maps and has contacted those townships to either return the maps with the modifiers marked or a certification that they do not plan to complete the maps. Chairman Anderson suggested that Sandy invite these three townships to the January 3rd meeting of the county commission. Sandy also reported on the 2006 state audit for FEMA projects. The report noted: that Sargent County has substantially completed the Project Worksheets; that sites totaling less than \$1,000 will NOT be de-obligated; and, that any balance of the 2006 funds due to the county road fund can be released to that fund based on submission of the paper work.

Approve Games of Chance Permit SC-2011-04 to Tewaukon Rod and Gun Club, Geneseo, ND for a raffle on January 13, 2012 at Geneseo Hall. (Jacobson/Waswick, unanimous)

Reappoint Janet Kiefer, Cayuga to represent Sargent County and reappoint Bill Anderson, Rutland to represent Sargent and Ransom Counties on the Southeast Human Service Center Regional Council for a two year term. (Walstead/Jacobson, unanimous)

Approve County Deed to Rocky Mountain LLC, Tempe, AZ for Lots 4-5, Block 5, Auditor's Plat, Crete Village for a purchase price of \$100.00. (Jacobson/Wyum, unanimous)

Approve transfer among the following 2011 budget fund: Capital Improvements to County Park \$15,000.00. (Walstead/Jacobson, unanimous)
