Motion to adopt the following snow emergency declaration: (Arth/Johnson) Roll Call Vote: Yes – Anderson, Arth, Bopp, Breker, and Johnson. No – None. Motion carried.

SARGENT COUNTY NORTH DAKOTA DECEMBER 20TH, 2022 SNOW EMERGENCY DECLARATION

WHEREAS: repeated snowfalls and multiple blizzards have occurred in Sargent County, imposing heavy burdens on farmers; ranchers; private businesses; individual homeowners; Townships; Cities and County road departments due to the amount of snow and the constant wind which plugs roads; and,

WHEREAS: The County Road Department; Townships; and Cities in Sargent County have expended most, in some cases all, of their funds budgeted for snow removal, and some Townships have now had to close all but the most essential roads due to lack of manpower and funding. Critical roads such as emergency routes, school bus routes etc. must be run several times most days; and

WHEREAS: The attempt to maintain access to these critical routes; farmyards; businesses; and, residences; has caused an inordinate amount of wear, tear and inadvertent damage to Township, City and County road equipment; has required an inordinate increase in the amount of fuel consumed, wages paid and overtime required; and, has also caused significant damage to collateral infrastructure such as school busses; and,

WHEREAS: The excessive cost of snow removal has generated unexpected contractor fees, equipment costs and employees' overtime, further depleting budgets.

NOW, THEREFORE, BE IT RESOLVED, The SARGENT COUNTY Commission declared that a State of Emergency exists in SARGENT County, its SARGENT County Emergency Operations Plan, its procedures and attachments to monitor the ongoing situation, mitigate where possible; and to provide protection to the citizens of SARGENT County during this ongoing event.

BE IT FURTHER RESOLVED, all local government agencies and departments are directed to provide protection to the citizens of SARGENT County during this event and limit, where possible, the hardships and impact of said emergency on the citizens and residents of Sargent County.

Calls were made to Steve Voightman, Oakes and to Dakota Valley Electric Co-op in Milnor, regarding the tower the county acquired through the tax forfeited property procedure. Mr. Voightman is willing to do some checking to see what the tower is worth and might be interested in purchasing it. Dakota Valley Electric stated that there is electricity in the vicinity, but the tower is not hooked up to electricity and hasn't been for some time. Commissioner Bopp did text Verizon to see if they would be interested in it, but hasn't received a response. Commissioner Johnson will drive by the site to see where the poles are located in the vicinity of the tower.

Motion to move the Weed Board portfolio to Wade Anderson. (Arth/Johnson) Upon roll call vote, motion carried.

Discussion about interested persons attending commission meetings. They may attend the meetings, but should not comment unless they are on the agenda and/or requested by the chairman to speak.

Discussion was held regarding Leave Without Pay for the custodian. Mr. Weaving will be traveling to England this summer and will not have enough vacation to cover his trip. Motion to allow up to two weeks Leave Without Pay. (Bopp/Arth) Upon roll call vote, motion carried unanimously.

Motion to give a full day holiday on December 23 (Christmas Eve Holiday) rather than a half day holiday as the policy allows. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Travis Paeper, Sheriff, arrived at the meeting.

A Beer and Liquor License Application was received from Jeremy Daggett for Dilly's Bar-N-Grill, Stirum. The application is not completed correctly, and there is not a township authorization or a map of the premises attached. Application was not approved. The Sheriff will contact the applicant and explain what is needed.

Steve Voightman called back into the meeting regarding the tower in Harlem Township. He stated that the tower is worth nothing according to Great Plains Tower in Fargo. It is worth salvage value only.

Tim Faber, Road Supervisor, arrived at the meeting. He would like to purchase an attachment for the motor grader that will take ice off the road. It is an eight foot blade with carbide teeth and will also work on washboards during the summer months. The cost is \$7500. Motion to purchase the Road Rage Motor Grader Attachment at a cost of \$7500. (Johnson/Bopp) Roll Call Vote: Yes – Arth, Bopp, Breker & Johnson. No – Anderson. Motion carried.

Michelle Denault, Human Resource Director, arrived at the meeting.

Commissioner Johnson brought forth revisions to the job descriptions for Road Equipment Operator and Road Equipment Operator III. Revisions/Additions as follows: Road Equipment Operator -Remove - Must possess a commercial driver's license; CDL preferred but not required. Replace with -Valid North Dakota Class B drivers permit with air brakes and Tanker endorsement by the first day of work or enrolled in a certification class and must obtain the North Dakota Class B driver's License with air brakes and tanker endorsement within 12 months of employment; Requires reporting to work within 30 minutes, after hours, on weekends, and on holidays during emergency events or inclement road conditions; Road Equipment Operator III - Remove - Requires a high school diploma or equivalent and a minimum of one year experience operating light, medium, and heavy equipment. commercial driver's license with airbrake and tanker endorsement. Must obtain certified training as required. Replace with the following: Valid North Dakota Class A drivers license with air brakes with a cargo tanker endorsement by the first day of work; Two years of relevant experience; Requires reporting to work within 30 minutes, after hours, on weekends, and on holidays during emergency events or inclement road conditions; Requires a high school diploma or equivalent; Must obtain certified training as required. Motion to approve the revisions and to approve that current employees are subject to the changes. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Holiday Day pay for essential workers was briefly discussed, but no policy change was made at this time.

New road department employees need some training on plowing snow. Our county looks better than some, but improvements can be made. Commissioner Anderson will get bus route maps to Mr. Faber for his information and Mr. Faber's number should be shared with all county schools and ambulance personnel. The commissioners advised Mr. Faber to keep all county roads open, but some could be closed temporarily, if necessary.

Some discussion was held with Sheriff Paeper if there was a better way to handle emergency closings of county buildings. Sheriff Paeper and Commissioners Arth and Bopp will discuss it further.
