The Sargent County Board of Commissioners met at 9:27 a.m. with the following members present: Jason Arth, Lyle Bopp, Mark Breker, and Jerry Waswick. Richard Ruch was absent. Also present Jayne Pfau, State's Attorney; Mary Engst, the Sargent County Teller; and, Pam Maloney, Sargent County Auditor.

Chairman Lyle Bopp called the meeting to order.

The Pledge of Allegiance was recited.

Approve February 2, 2021 minutes as presented. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

Alison Toepke, Treasurer/Recorder/Clerk of Court, arrived at the meeting to request authorization to add the new deputy auditor, Teddie Lee to the signature card at the bank. Motion to authorize Teddie Lee, Deputy Auditor, to sign signature cards at the local financial institutions to enable her to sign warrants for payment of bills; and, to remove the name of Heidi Johnson, former Deputy Auditor from the signature cards. (Arth/Breker) Upon roll call vote, motion carried unanimously.

The Parental Leave policy was briefly discussed. Commissioner Waswick will look for more information.

Some discussion was held regarding the Human Resources Director position. Ms. Mulder's input is needed before a decision can be made.

Wendy Willprecht, Emergency Manager/911 Coordinator, arrived at the meeting. Brenda Peterson, Health Unit Administrator, joined the meeting through technology. Ms. Peterson stated that there are 6 active cases in Sargent County at this time. Vaccinations are going well. The next phase of vaccinations will include school staff, as the 65 & over group is almost completed.

Ms. Willprecht stated that she had heard from Gwinner & Rutland Fire Departments regarding the Emergency Management Trailer. Neither of these departments have the room or the resources to take responsibility for it. The commission would like Ms. Willprecht to contact Milnor and Forman Fire Departments again, to see if they would take ownership. If not, the trailer will be sold or traded for a smaller one to be used for road department purposes.

Ms. Willprecht also provided the commissioners with further information on siren requests. The county is allowing a 50% cost share to cities within the county that are installing new sirens or repairing old ones. Milnor and Forman have submitted requests for cost share on new sirens. Total reimbursement would be approximately \$21,233.55.

Motion to approve Raffle Permits to the Sargent Central High School Trap Team, Forman, for a raffle to be held March 13, 2021 at the Rutland Sportsman's Club, rural Rutland; and to CHS Dakota Plains Ag, Gwinner for a raffle to be held March 20, 2021 at CHS Dakota Plains Ag, Gwinner. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

The commissioner reviewed three Omitted Property adjustments. The first property is Parcel 25-7383004 which had a veteran's credit applied, but does not qualify in 2020. The taxpayer did not contest the addition. The second property is Parcel 31-9354000. This, too had a veteran's credit applied, but does not qualify in 2020. The taxpayer did not contest the addition. The third parcel is 29-9067001, which also had a veteran's credit applied, but the application had not been returned for 2020, although a veteran does still live on the premises. Motion to add the omitted properties of Parcels 25-7383004 & 31-9354000 to the tax rolls for 2020 at the values determined by the tax director and the auditor, but to keep the veteran's credit on Parcel 29-9067001. (Waswick/Breker) Upon roll call vote, motion carried unanimously.

Commissioner Bopp had been approached by the Forman City Auditor regarding a Community Forestry Grant. This grant would replace trees that had to be removed due to disease last summer. Motion to request up to 20 trees for the courthouse lawn. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

The board reviewed the letter from Ohnstad Twichell Law Office regarding the Application for Surface Drain No. 5503, in which the Dickey County Highway Department seeks to convert an existing emergency surface drain permit to a permanent Surface Drain Permit. No action was needed.

Motion to approve electrical work in the Commissioner's Room to allow for the teleconferencing equipment that will need to be added to that space – approximate cost being \$500. (Waswick/Arth) Upon roll call vote, motion carried unanimously. It was suggested to add an HDMI cord to the work being done.

The auditor was instructed to set up non-agenda meetings between the commissioners and the departments for the afternoon of March 2nd.

Ted Keller & Leo Straley, General Roofing & Construction, arrived at the meeting to present a proposal for the courthouse cornice repair and restoration project. This would also include the removal of asbestos sealants in the cornice shelf and fixing the roof leak issues in the elevator addition. They explained the issues that needed to be addressed, along with a projected timeline and cost to be incurred. Total cost for this project is \$188,467. Motion to move forward with the Sargent County Courthouse Cornice Repair and Restoration Project at a cost of \$188,467. (Waswick/Breker) Upon roll call vote, motion carried unanimously.

Austin Creech & Ryan Johnson, representing the Gwinner First Responders, arrived at the meeting. They are requesting that Sargent County would recognize them as a governmental entity, as they recently had to garner insurance coverage, & it was difficult to get as they were not a governmental entity. They would be operating under the Sargent County Ambulance-Milnor Squad, with the coordinator serving as their director, as they already work with the Milnor Squad on ambulance calls. The Gwinner First Responders and Brian Tayer, Milnor Ambulance Squad Coordinator, will need to execute an agreement between them stating the Gwinner First Responders are a Sargent County governmental entity and their director will be the Sargent County Ambulance-Milnor Squad coordinator, along with any other terms or stipulations they need. Motion to allow the Gwinner First Responders to become a Sargent County Entity, under the umbrella of the Sargent County Ambulance-Milnor Squad with terms to be determined between the Gwinner First Responders and the Milnor Ambulance Coordinator. (Arth/Waswick) Upon roll call vote, motion carried unanimously.

Tim Faber, Road Supervisor; & Loy Justesen, Equipment Operator; arrived at the meeting. Commissioner Arth had provided the board with a listing of equipment needs, along with their projected costs. He also provided a list of equipment that could be sold and an approximate graveling cost for this summer. Several pieces of equipment need to be replaced. Motion to approve a lease/purchase agreement for the equipment items with Sargent County Public Finance up to \$360,000, with terms to be determined. (Waswick/Arth) Upon roll call vote, motion carried unanimously.
