Motion to move into executive session pursuant to North Dakota Century Code 44-04-19.1 for the purpose of consulting with the state's attorney regarding the Jacobson settlement. (Anderson/Walstead, unanimous) (Approximately 10:20 a.m.) Executive session ended and regular meeting resumed at 10:30 a.m.

A motion was made to enter into a tractor rental contract with Green Iron Equipment of Milnor ND through the North Dakota Association of Counties tractor rental program with John Deere. (Anderson/Walstead, unanimous). Bruce Peterson of Green Iron Equipment had stopped in at the Auditor's Office stating that he needs a letter on Sargent County letterhead stating the terms of the contract. The rental contract will be for 8 months, 250 hours, @ \$15.35 per hour, plus \$2.00 additional loader fee for 8 months totaling \$4,337.50. The Auditor's office will get the letter of intent written.

The possibility of obtaining some bridge replacement funding from the Federal Lands Access Program (FLAP) in cooperation with the Tewaukon National Wildlife Refuge was discussed briefly. Commissioners Anderson and Walstead, County Engineers Devillers and Sedler; and, Road Supervisor Engquist had met with Tewaukon Refuge Manager Kent Sundseth at the Refuge Headquarters on Wednesday, February 15, to discuss possible projects. Damon DeVillers, Interstate Engineering, will be getting together with ND DOT to check on eligibility and funding match for 2 possible projects, one over LaBelle Creek on the southeast side of Lake Tewaukon, and the other over the Wild Rice River north of Sprague Lake.

Further discussion on Colonial Life Insurance was tabled until a later date.

A motion was made to accept Richard Engst's resignation from the Sargent County Water Resource Board, with thanks for 19 years of service, and direct the Auditor to advertise for applicants for the position. (Anderson/Arth, unanimous)

The Commission had received applications for two abatements of taxes. The first abatement application was for Tyler & Betsy Speich, requesting abatement of taxes on a residence on the SW1/4 of NW1/4 of SW1/4 2-131-53 for farm exemption, Herman Township had approved the application for abatement. The second was for Dale Keller, requesting correction of a new home exemption error on NE1/4 of NE1/4 of NE1/4 07-2534002, Harlem Township had approved the application for abatement. Motion to concur with the townships on both applications. (Anderson/Arth, unanimous)

Marwood Klein, Forman Ambulance Squad Coordinator for the Sargent County Ambulance Service, met with the commission to report on Forman Ambulance Squad activity. He stated that the squad is doing OK with current staff, but that more volunteers could certainly be used. Some discussion on new ambulance options was had, as the ambulance had been in the shop to deal with some serious, recurring engine issues. Intercepts were discussed, including existing protocols that direct when and why they should be used. Marwood stated that there had been 69 runs this year and there have been no issues with billing. The commissioners thanked Marwood for his report, and commended him and the members of the Forman Ambulance Squad for their work on behalf of the people of Sargent County.

A brief discussion was held on a Forman citizen's concerns about deer crossing the State highway North of Forman. Jason Arth had emailed this citizen and directed him to contact the State Highway Department, as the County has no authority to place signs or other traffic controls on State highways.

Merrill Engquist, Road Supervisor, arrived at the meeting. Mr. Engquist reported that they have been doing some gravelling on County #1, to fill deep ruts left by grain trucks just before freeze-up last Fall, and some touch ups by the Delamere Dairy road. He also stated that the County Road crew would be putting road restriction signs on today, Tuesday, February 21.

A motion was made to authorize the 2017 Relay for Life Committee to use the courthouse lawn for the event on Friday June 23, 2017 (Anderson/Walstead, unanimous)

Motion to send a letter to the North Dakota Highway Patrol Weight Enforcement Unit requesting assistance with weight enforcement on county roads. (Walstead/Arth, unanimous)

A motion was made to remove inventory items #2676-Printer, #2389-Radio and #2967-Laptop computer. (Anderson/Arth, unanimous)
