Forman, North Dakota February 21, 2023

The Sargent County Board of Commissioners met at 8:30 a.m. with the following members present: Jason Arth, Mark Breker, and Scott Johnson. Wade Anderson and Lyle Bopp were absent. Also present was Richard Ruch, County Resident; and Pam Maloney, County Auditor.

Chairman Mark Breker called the meeting to order.

The Pledge of Allegiance was recited.

Motion to accept the agenda as amended. (Arth/Johnson) Motion carried.

Motion to approve the February 7, 2023 minutes as presented. (Johnson/Arth) Motion carried.

Commissioner Anderson arrived at the meeting.

Michelle Denault, Human Resources Director, arrived at the meeting. She provided a "New Hire" letter she had composed for the Sargent County Ambulance-Milnor Squad new employee that will be signed by the employee, county commission board chairman, ambulance coordinator and the human resources director. The commissioners approved the letter.

Travis Paeper, Sheriff; and Heidi Johnson, Deputy Matron; arrived at the meeting. Discussion was held regarding payroll errors for three employees when receiving a step increase in 2022. This resulted in an overpayment to these employees. The auditor explained what had happened within the software program. A request was made to forgive these overpayments. The Sargent County Employee Handbook states that overpayments will be corrected either in the next paycheck or over a schedule of repayments to minimize the burden to the employee. The commissioners would like to see additional information/documentation on how the error had happened before making a decision.

Jayne Pfau, State's Attorney, arrived at the meeting.

The commissioners opened the bids for the tower demolition in Harlem Township. The bid was for the demolition and removal of a communications tower situated on the NE1/4 of Section 19-131-57. The tower and cables will be demolished, cleaned up and removed by July 1, 2023. One bid was received from Isaiah Throener in the amount of \$5,000. Motion to accept the bid from Mr. Throener in the amount of \$5,000, contingent upon landowner approval to access the tower for removal and that the bidder signs a contract. (Johnson/Arth) Upon roll call vote, motion carried unanimously.

The commissioners proceeded to open the bids for surplus property that was advertised for sale. Motion to accept all high bids for those items and that those items need to be picked up by March 1st; items not sold should be disposed of as soon as possible. (Anderson/Arth) Upon roll call vote, motion carried unanimously. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Sheriff Paeper requested permission to sell surplus handguns to his staff. These guns cannot be sold to the public as surplus property. Motion to allow the sheriff to sell surplus handguns to members of the Sargent County Sheriff's Department (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Commissioner Johnson stated that he had drafted a policy regarding pay for essential workers during times when county buildings are closed due to weather related or other emergencies. Ms. Pfau has approved the draft – it will now go to Ms. Denault for her to present it to the Personnel Board for their approval.

Emergency and weather closing notifications will continue as they have in the past with the sheriff making the calls to department heads.

Ms. Pfau will be reaching out to other counties to see if any have a Road Use and Maintenance Agreement form that can be used for SCS Carbon Transport, LLC. She and Damon DeVillers, Interstate Engineering, have concerns with the form provided by SCS Carbon Transport, LLC.

Tim Faber, Road Supervisor; and Scott Wermerskirchen, Minn-Kota Communications, arrived at the meeting to discuss radios for the highway department. He provided a quote for 22 mounted in-vehicle radios for a cost of \$56,274.75. The county would receive reimbursement from the state in the amount of \$33,000, leaving a net cost of \$23,274.75. Mr. Wermerskirchen stated that handheld radios are somewhat cheaper, but would require more maintenance, such as charging and replacing batteries. After further discussion, it was decided to request a new quote to discuss at the next meeting. Commissioners Johnson & Arth, along with Mr. Faber, will determine how many mount-in and handhelds should be quoted.

LaJuana Hayen, Tax Director, arrived at the meeting. There was one application for abatements that needed to be addressed. Parcel 31-0000020 – 1971 Dekco 14 x 67 Mobile Home. The applicant, Robert Hamman, requests that the taxes for 2023 be abated as the mobile home has been destroyed. The tax director confirmed the demolition in January with a drive-by. Gwinner City has approved the abatement application. Motion to concur with Gwinner City. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Further discussion was held regarding reimbursement to the Milnor Ambulance Squad for the ambulance they gifted to the Gwinner First Responders. Brian Tayer, Sargent County Ambulance-Milnor Squad, sent an email showing a trade-in value of \$65,000 for the Horton Type 1 4x4 ambulance unit that he had received from Premier Specialty Vehicles. Motion to deny the request for reimbursement as proper procedure wasn't followed. (Anderson/Arth) Upon roll call vote, motion carried unanimously.

Further discussion was held regarding the estimates provided by Interstate Engineering for different road projects that the county would be able to use Prairie Dog Funds for. Motion to move forward with Patching, Crack Filling and Seal Coat on County Road #12 from County Road #1 south 6 miles to ND State Highway 11; and on County Road #4 from ND State Highway 13 south 8.5 miles to ND State Highway 11 for an approximate cost of \$1,398,010.92. (Anderson/Johnson) Upon roll call vote, motion carried unanimously. The county has received \$1,297,648.50 in Prairie Dog funds.

Commissioner Arth stated that he had received several questions and comments regarding dust control on county roads. The auditor will check the letter that went out to the townships in their annual packet & make sure there is information on the letter regarding the dust control in the future.

Mr. Faber stated that he had taken the Hoving road home recently and there was a train blocking the road. There are no warning lights or other safety equipment at that crossing. The commission directed him to talk with Wendy Willprecht, Emergency Manager/911 Coordinator.

Ms. Denault provided further information regarding Policy 706 – Attendance and Punctuality. She provided some clarification regarding the "No Call/No Show" and the "Call-in Policy" that she had received from another county. She will take the policy change back to the Personnel Board for their approval before bringing back for the commissioners to act on.

Motion to approve a Raffle Permit for the Tewaukon Rod and Gun Club, Geneseo, for a raffle to be held February 21, 2023 through April 4, 2023, drawing date. (Anderson/Arth) Upon roll call vote, motion carried unanimously.

Motion to authorize the chairman to sign an Audit Engagement letter from the Office of the State Auditor. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Motion to approve and authorize the chairman to sign EAP Full-Service Contract for Services with The Village Business Institute for the term of January 1, 2023 to December 31, 2025 at a cost of \$1500/year. (Arth/Anderson) Upon roll call vote, motion carried unanimously.

Motion to re-appoint Julie Colemer to the Sargent County Park Board – term ending January 1, 2026. (Anderson/Johnson) Upon roll call vote, motion carried unanimously. No other applications were received.

Commissioner Breker requested clarification on who is responsible for road signs within the county. Signs on county roads are the responsibility of the county – signs on township roads are the responsibility of the township.

State's Attorney Pfau stated that some pharmacies are wanting to settle their opioid lawsuits. She has received a letter from our opioid litigation attorneys and they are recommending that we take the settlement. Motion to accept the settlement and to grant Ms. Pfau permission to sign any documents needed for this settlement action. (Anderson/Arth) Upon roll call vote, motion carried unanimously.
