Motion to extend part-time road help through 2025 for three employees at 20 hours per week with the same being reviewed at the second meeting in December 2025. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Motion to purchase snow tires and rims for the JCB tractor. (Waswick/Johnson) Voting yes were Arth, Waswick and Johnson. Voting no were Bopp and Anderson. Motion carried.
