The Sargent County Board of Commissioners met on Tuesday, June 17, 2025, at 9 a.m. at the Sargent County Courthouse. Those in attendance were Commissioners Jerry Waswick, Scott Johnson, Lyle Bopp, Jason Arth and Chairman, Wade Anderson. Also, in attendance were Jayne Pfau, State's Attorney; Tia Bopp, Auditor; and Duane Peterson, Human Resources Director.

Chairman Anderson called the meeting to order.

The Pledge of Allegiance was recited.

Motion to approve the agenda with additions. (Waswick/Johnson) Motion carried.

Motion to approve the minutes from June 3, 2025; June 6, 2025; June 9, 2025; June 10, 2025 (2); and June 12, 2025. (Johnson/Arth) Upon roll call vote, motion carried unanimously.

The Board of Commissioners went in to executive session per NDCC 44-04-19.1 at 9:07 a.m. and came out of executive session at 9:23 a.m. Those present during executive session were the five commissioners, Jayne Pfau, State's Attorney, and Tia Bopp, Auditor. Duane Peterson, left the meeting during the executive session.

Motion to pay the amount remaining on the 40% cost-share for the Drain 11 crossing improvement costs, in order to avoid the Sargent County Water Resource District from defaulting on its bond obligations and avoid a deficiency levy. (Johnson/Waswick). Commissioner Bopp is opposed to the county paying for the Water Board's attorney giving wrong advice to the Water Board. He feels this should be turned over to NDIRF. Voting Yes were: Commissioners Arth, Johnson and Anderson. Voting no were Commissioners Bopp and Waswick.

Duane Peterson arrived back at the meeting at 9:27 a.m. Mr. Peterson reported he had talked to the two employees that are currently in the DC 2025 retirement plan through PERS. Motion to ask Jayne Pfau, State's Attorney to draft a resolution, to withdraw from the ND PERS 2025 DC Plan and give employees an option on who they want to enroll with. (Bopp/Arth) Upon roll call vote, motion carried unanimously.

Motion to approve Jeremy Daggett's Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises. (Johnson/Bopp) Upon roll call vote, motion carried unanimously.

Motion to approve and authorize the Chairman to sign the Construction Agreement and Notice to Proceed for project: Bituminous Patching CP-4101 (025) Sargent County, ND ER25-00-020; Construction Agreement and Notice to Proceed for project: Mastic Crack and Seal Repair County Road 10 CP-4125 (025) Sargent County, ND ER25-00-022.01; Construction Agreement and Notice to Proceed for project: In-Slope Flattening County Road 12 Sargent County, ND ER25-00-021; and the Progressive Estimate #1 (Final) for 3-D Specialties for the 2025 Pavement Marking Project. (Waswick/Johnson). Upon roll call vote, motion carried unanimously.

Motion to proceed with the summer fill and prepay program as recommended by CHS utilizing the three-year consumption average and apply any unused credit to the summer fill. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

A request was received by an employee in the courthouse to bring their pet to work for the week as the dog is recovering from surgery. Motion to allow the employee to bring their pet into the office as long as the appropriate paperwork is filed in the auditor's office and approval is obtained from their department head. (Johnson/Bopp) Voting yes were: Commissioners Arth, Waswick, Johnson and Bopp. Voting no: Chairman Anderson. Motion carried.

Discussion was held regarding the need to replace the snowplow truck. The road supervisor was instructed to start looking to see what is available and report back to the commission.

The HB 1776 Budgeting with Caps seminar was discussed briefly.

A recess was taken from 9:43-9:50 a.m. Tim Faber, Road Supervisor arrived at 9:47 a.m.

Motion to approve an Application for Drainage Work Within County Road Right of Way as was submitted by Aaron Beaner after verification that a hydrology study had been completed. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Discussion was held regarding County Road 1. No action will be taken at this time.

Damon DeVillers, Interstate Engineering, arrived at the meeting at 9:56 a.m.

Mr. Faber informed the Board the crack sealing will be done at noon. The contractor informed Mr. Faber that there is still product left that would allow them to finish County Road 14 with some additional oil for \$56,000. Motion to proceed with finishing County Road 14 with the left-over material for a cost of \$56,000 upon receipt of a written change order and allowing the Chairman to sign the same. The cost of this would be covered with Prairie Dog funds. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

Mr. DeVillers shared there are no updates on the flex applications. Mr. DeVillers did provide a map to be used for planning purposes so projects can be prioritized when the flex applications do come out.

There is a NDIRF meeting coming up that Commissioner Bopp would like to see as many attend as possible.

Motion to pay the June payroll in the amount of \_\_\$322,880.29\_ and the bills as presented. (Johnson/Bopp). Upon roll call vote, motion carried unanimously.
