Forman, North Dakota March 16, 2021

The Sargent County Board of Commissioners met at 9:18 a.m. with the following members present: Jason Arth, Mark Breker, Richard Ruch, and Jerry Waswick. Lyle Bopp was absent. Also present was Bruce Berg, Butler Machinery; Tim Faber, Road Supervisor; Jayne Pfau, State's Attorney; Mary Engst, the Sargent County Teller; and, Pam Maloney, Sargent County Auditor.

Vice-Chairman Richard Ruch called the meeting to order.

The Pledge of Allegiance was recited.

Motion to approve the agenda as amended. (Arth/Breker) Motion carried unanimously.

Brenda Peterson, Health Unit Administrator, joined the meeting through technology. Ms. Peterson stated that there are 3 active cases in Sargent County at this time. She stated that approximately 30% of county residents have been vaccinated to date. The health unit has stopped Covid testing on Wednesdays to concentrate on vaccinations, as the rapid tests are being held in Gwinner throughout the month of March.

Jill Mulder, Human Resources Director, arrived at the meeting. Motion to extend the Emergency Paid Sick Leave for Covid related reasons until June 30, 2021. (Waswick/Arth) Roll Call Vote: Yes – Arth, Breker & Waswick. No – Ruch. Absent & not voting – Bopp. Motion carried.

Motor grader bids were opened. Bruce Berg gave a short representation on the Caterpillar machine. Commissioner Arth will compile a comparison spreadsheet of the two bids & a decision will be made at the next meeting on April 6<sup>th</sup>.

Kristine Radke, Walock-Johnson Insurance Company; & Corey Olson, NDIRF; arrived at the meeting to discuss insurance increases on the county & park's buildings. The commission can choose to increase anytime and can also choose which buildings to increase. Mr. Olson has offered to come down later in the spring & look at the county's buildings to put a more accurate insurance value on them before the July 1 renewal. Motion to increase the courthouse building coverage up to \$10,000,000 effective today. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

Jesse Mastenbrook & Nathan Schlecht, Forman Community Development Corporation; arrived at the meeting to discuss a project they are considering. They are proposing to construct a new clinic building and were wondering if the county would like to incorporate the District Health Unit and/or an ambulance garage into the plans for the building. The board was interested in the idea and will visit with the health unit administrator and the ambulance coordinator to get their opinions. There has been an idea for many years that the Forman Fire District would build a new building that could possible house the ambulance, so Mr. Mastenbrook & Mr. Schlecht will also have some communication with them regarding this project.

The board proceeded to open bids for furnishing supplies for the year beginning April 1, 2021, and ending March 31, 2022, as advertised. All bids submitted, including exact wording and amounts, are available for inspection at the office of the county auditor. Bids submitted as follows:

**GRAVEL:** Crandall Construction Inc., Cayuga; William Beaver, Forman; Bernard Mahrer Construction Inc., Rutland; Lesmeister Gravel, Inc, Lisbon; Mark Sand and Gravel Dakota Co., Fergus Falls, MN; and, Enderson Construction, Inc. Gwinner. Motion to accept all gravel and hauling bids. (Waswick/Arth) Upon roll call vote, motion carried unanimously.

MIXING & DRYING BLACKTOP SURFACING: No bid received.

BITUMINOUS MATERIALS: No bid received.

**GASOLINE, FUEL, & LP GAS:** Rutland Oil Co., Rutland, and CHS Dakota Plains Ag, Kindred. Motion to accept all bids. (Arth/Breker) Upon roll call vote, motion carried unanimously. Discussion was held regarding the Human Resources Director shared position. Ransom County has terminated their contract with Ms. Mulder. Motion to offer Ms. Mulder 20 hours/week at Sargent County. (Waswick/Arth) Vote tabled until Commissioner Bopp can be present.

Meeting recessed for lunch break.

Meeting resumed at 1:15 p.m. Commissioner Breker had a previous commitment & did not return after lunch.

Lonny Bosh and Amber Schriock, NRG Technology Services; arrived at the meeting via technology to discuss migrating the on-premise Exchange server to an online Exchange server. This move and the addition of hard drive space would make it possible to migrate the entire server to a new partition in an effort to remove the Zero Day Exchange threat that recently swept the United States. This would also reduce the cost of the server replacement next year since the Exchange migration would already be done. After much discussion, no decision was made, but NRG will be sending a revised quote that the commission will discuss at their next meeting, April 6<sup>th</sup>.

The commissioner reviewed several Omitted Property adjustments due to Farm Home Exemption paperwork not being filed. Motion to approve the following Open Burning Resolution and Ordinance: (Waswick/Arth) Upon roll call vote, motion carried unanimously.

## **Sargent County Open Burning Resolution and Ordinance**

Whereas, drought conditions are possible in Sargent County throughout the Spring of 2021; and,

Whereas, the danger of open fires escaping from their intended locations to endanger property and lives in Sargent County are enhanced by dry conditions and high winds; and,

Whereas, Counties are authorized by State Law to institute regulations to govern open burning within their jurisdictions, including the imposition of penalties for violations of the same;

Now, therefore, be it resolved that, effective March 16, 2021, and continuing until amended or rescinded by action of the Sargent County Commission:

Burning is allowed, without permission, when the daily fire rating is set at "LOW or MODERATE".

NO BURNING WILL BE ALLOWED when the daily fire rating is set at "HIGH-VERY HIGH- OR EXTREME".

## NO BURNING WILL BE ALLOWED when there is a "RED FLAG WARNING".

"No Burning" includes, but is not limited to charcoal grills, fire pits, contained garbage, grass, any type of burn in which the flame, coals or embers are not fully contained in a masonry or metal firebox.

Penalties will be enforced as set forth in NDCC Section 37-17.1-10.1.
