The Sargent County Board of Commissioners met at 10:15 a.m., following the meeting of the Sargent County Park Board, with the following members present: Mike Walstead, David L Jacobson, Jerry Waswick, Steven Wyum and Bill Anderson. Absent: None. Also present was Paige Cary, the Sargent County Teller.

Travis Paeper, Sheriff met with the commissioners to discuss the recently adopted Distracted Driving Policy. Sheriff Paeper is concerned about the language of the policy. Motion that the implementation of the Distracted Driving Policy be temporarily suspended pending receipt of proposed amendments that are to be prepared by Sheriff Paeper, States Attorney Bopp and Commissioner Steve Wyum. (Anderson/Waswick, unanimous)

Clara Rebel and Morgan Eberhardt, Sargent County Social Services met with the Commission to request permission to place ribbons on trees on the courthouse lawn to commemorate May as Foster Care Month. There are currently 1142 Foster Care children in North Dakota with 3 of those being from Sargent County. There are presently no foster care homes in Sargent County. Clara and Morgan explained the procedure for becoming a Foster Parent. Authorize placement of ribbons on trees on the courthouse lawn to commemorate Foster Care Month. Sandy Hanson, Tax Director, met with the Board regarding an Application for Abatement and Settlement of 2012 Taxes from Donald Patterson; parcel # 20-6153000 – a 4 acre parcel located in Section 33-131-58. It was noted by the landowner that the property was erroneously being taxed in the Sargent Central School District instead of the Oakes School District. It was determined that the property is located within the boundaries of the Oakes School District. Mr. Patterson is requesting that the taxes be recomputed with the correct tax levy. Verner Township approved the abatement. Motion to concur with Verner Township. (Anderson/Walstead, unanimous)

Following discussion on the Milnor City Renaissance Zone Abatement applications approved at the April 2, 2013, Commission meeting, and based on an opinion of the Sargent County States Attorney that Renaissance Zone properties are eligible for no more than a 5 year property tax exemption, and based on information obtained by the County Auditor subsequent to the April 2 meeting that the properties had already received five years of exemption, a motion was made to rescind the April 2 motion concurring with Milnor City with regard to the three Aberle properties in Milnor City's Renaissance Zone. (Anderson/Wyum, unanimous)

Sandy Hanson also reported that she has not had any response from FEMA on the request to utilize monies that were approved for repair of a bridge site across the Wild Rice River in Herman Township from the 2009 flood disaster. The Board has 60 days to consider the bids for the repair of the Herman Township Bridge site that were received on March 29. FEMA repair funds from the 2010 flood disaster are available for the project, as long as the repairs proposed meet the scope of work requirements approved by FEMA, Sandy reported.

Sparky Engquist, Road Supt. met with the Board and provided a map of county roads that the road department intends to gravel this year. Discussion followed on the quality of gravel to be used on County roads, and the required testing of all gravel pits to assure that the proper class of gravel is delivered for use on Sargent County's roads. Road Commissioner Mike Walstead reported that Interstate Engineering will be testing the quality of gravel from the various pits which will be supplying gravel to the County Road Department. Steve Wyum asked if Sargent County has a policy governing the placement of culverts through county roads to facilitate field tile drainage projects. Motion to have Sparky Engquist, Lyle Bopp, Mike Walstead and Damon DeVillers, County Engineer; prepare a draft policy for review by the Commission. (Wyum/Anderson. Motion carried.) Sparky reminded the Board that a policy concerning ditch cleaning work on County road rights-of-way is currently being worked on that could include policy provisions concerning culvert placement.

Mike Walstead brought up needed repairs to County Road #10 through Milnor, which is also Milnor's Main Street, and asked if there are any County/City agreements in place concerning the division of costs for making repairs. The Board instructed Mike to contact County Engineer Damon DeVillers, Interstate Engineering. Inc. and Milnor City to discuss the potential cost of the needed repairs and contributions that might be required of both the County Road department and the City. Sparky reported that nothing has been heard from ND-DOT as to whether any of the county railroad crossings have been considered for funding under the repair and replacement program.

Jeff Breker, Tewaukon Township Road Supervisor met with the commissioners to discuss two bridges in that township that the Board of Supervisors considers to be hazards to the public safety. Bridge 129-24.1 located between Sections 21/22 is a deteriorating timber bridge structure. Sparky Engquist stated that the hydraulic study had been completed at this site, and the road department is working on replacing this bridge with a metal culvert. Also, according to Jeff Breker, Bridge 128-22 located between Section 8/9, Township 129, Range 54 LTL is a wood structure that is hazardous because it is currently not marked and is narrower than the road. The township is requesting that the county remove the bridge and place a 30" culvert at this location. Frenier Dam controls most of the water in this area and a small culvert should solve the problem. The township plans to do work on this road this year and they would like the bridge removed before they commence work. Mike Walstead will talk to the county engineer to prepare a hydraulic study of this site.

Approve Gaming Site Authorization to American Legion Bullis Post #84, Lidgerwood, at Geneseo Bar and Café beginning July 1, 2013 and ending June 30, 2014. (Anderson/Walstead, unanimous)

Sargent County Auditor Hosford reported that the County had received a check for payment of the county's share in the 2012 Conferment of Benefits declared by the North Dakota Insurance Reserve Fund Board of Directors in the amount of \$6,714.

Reappoint Dr. Rup Nagala to a five year term on the Sargent County District Board of Health. (Walstead/Anderson, unanimous)
