The Sargent County Board of Commissioners met at 9:45 following the Non-Agenda Employee Meeting held at 9:00 with the following members present: Wade Anderson, Jason Arth, Lyle Bopp, Mark Breker, and Scott Johnson. Also present was Jayne Pfau, State's Attorney; Richard Ruch, County Resident; and Sharon Halmrast, County Chief Deputy Auditor.

Chairman Mark Breker called the meeting to order.

The Pledge of Allegiance was recited.

Motion to accept the agenda as amended. (Anderson/Arth) Motion carried.

Motion to approve the April 10, 2023 minutes. (Arth/Anderson) Motion carried.

Michelle Denault, Human Resources Director, and Dan Aubol, Independent Agent for Colonial Life arrived at 10:00. Mr. Aubol presented rate comparisons and benefits for Dental Insurance thru Colonial Life and the County's current plan. He also presented options for Supplemental Insurance Policies that employees can obtain with Colonial Life through payroll deductions. Motion made to offer supplemental insurance policies to employees but County Dental Policy would remain with current provider. (Bopp/Arth). Roll call vote as follows: YES-Johnson/Bopp/Arth. NO-Anderson/Breker. Motion carried. Ms. Denault, Human Resources Director will schedule a time to invite employees to review these new supplemental insurance policies.

Discussion on the EMS Structure was tabled until further clarification on position roles are available.

Carbon Summit Road Crossing Application was presented for signature, discussion held on the forms submitted. Jayne Pfau, State's Attorney, will review further and send out proper road use forms to be completed by Carbon Summit and signed in the future when those forms are returned.

Tim Faber, Road Supervisor arrived at 10:08.

Commissioner Anderson and Commissioner Breker brought forth county road issues they had received calls on or locations that they had visited. Main concerns were the public's ignorance of road closure postings. County residents were going through barricaded roads even as road crews were working on them. Ms. Pfau, State's Attorney, informed the commission of the procedures on road closures temporarily due to hazardous conditions for the protection and safety of the public and the penalty for those ignoring posted closed roads which is a Class B Misdemeanor. *N.D.C.C.* § 39-10-21.1

2023 Contractor Gravel Plans were presented and reviewed. Motion to approve said plans as presented. (Arth/Anderson). Upon roll call vote, motion carried unanimously.

An Application for Drainage Work Within County Road Right-of-Way was received from Gary Anderson, Cayuga, to cut county road #12 between Tewaukon Township Section 13 and Marboe Township Section 18 to install a tile main. County will seek opinion on applications as presented from County Engineer. Commissioner Anderson will contact landowner with engineer's response so he may submit new drainage applications. Motion to deny drainage applications as presented. (Johnson/Bopp). Upon roll call vote, motion carried unanimously.

County Highway Road Shop drainage issues were discussed. Some work had been done to try to resolve the non-functioning drainage and solution suggestions were presented. Commission would like to seek a second opinion on the matter and bring it to next meeting.

Commissioner Arth had received a request for a letter of Commissioner's support from Carol Peterson, Milnor City Economic Development Coordinator in favor of extending Milnor City's Renaissance Zoning. Motion made to send support letter to Milnor City. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Travis Paeper, County Sheriff and Tyler Newborg, County Resident and Former President of Sargent County Fair Board, arrived at 11:15.

Sheriff Paeper requested permission to bring the 2016 retired squad car to auction. Motion to approve sale of retired squad car through auction. (Arth/Johnson) Upon roll call vote, motion carried unanimously.

Tyler Newborg, not speaking on behalf of Sargent County Fair Board, asked to speak to commission about procedure followed to place emergency sandbagging sand in a designated fair building. He stated his opinion. No action taken.
