Bill Anderson reported on the Commissioner's visit with the N.D. legislators in Bismarck on Transportation Day, April 15th, to discuss and encourage support of the Highway Funding bill. Townships and cities with less than 5000 population will get no Stimulus money. They felt encouraged that most legislators were open to working together in the transportation funding effort. It was discouraging that the majority party's leadership in the House of Representatives seemed, at the time, to be unwilling to recognize the transportation needs of rural North Dakota. Continued persuasion may bring them around.

Mark Gainor, Milnor Airport Authority, and Jayson Gainor discussed a request for \$5000 funding for the Milnor Airport within the County's Airport Authority levy. The budget

request of approximately 1/3 mill would be considered in the 2010 budget. Commissioner Anderson commended the Airport Authority on the work being done to revitalize the airport for more efficient usage for the Milnor community and all county residents. Mark expressed the Milnor Airport Authority's appreciation of the cooperation received from the Sargent County Commissioners. A copy of the Airport Authority's budget and a copy of the Airport Authority's improvement plan were left with the County Auditor.

Lyle Bopp, States Attorney arrived at 10:35 a.m.

Marwood Klein, Sargent County Ambulance, discussed CPR/AED certification of county employees, and the Commissioners support and strongly encourage all employees to take the classes to be held the week of May $4 - 7^{\text{th}}$. Sandy Hanson, EMS/911, added her support.

Sandy Hanson spent time in the flood fighting work in Lisbon, LaMoure, Dickey, and Cass. She'll be contacting townships and cities to get the appropriate paperwork submitted for FEMA projects. Two townships had applied for funding under the Snow Emergency Declaration. Sandbags are stored at the county shop.

Julie Hassebroek, Extension, and Roger Haugen, District Director, reported that Ms. Hassebroek had discussed the entry dates and deadlines issues with Ken Forster, and they had resolved their differences and are moving to the future. The 4-H Council has set the sanctions and won't be changed for the current year. Ideas to improve the program or participation can be brought to the 4-H Council for consideration. Mr. Haugen stated that Sargent County has a very strong 4-H program. The County commission values the 4-H program provided to the youth of the County, and the hard work of the many volunteers, such as Mr. Forster, who help make the program successful.

Lyle Bopp discussed the proposed liability wording to be included in the Airport Authority contracts with Gwinner City and Milnor City. He will check with the entities on concerns.

The board recessed at 12:05 p.m. for lunch, and reconvened at 2 p.m. following Sargent County Park board meeting. Lyle Bopp and Holly Jessen left the meeting.

Russell Martinson and Scott Mund, Hall Township, met with the Commission and discussed options to provide an access to a farm site from which the family has been displaced due to washout of township road near a county bridge (#135-5.2). County Engineer Damon DeVillers had discussed this project with NDDOT and presently there is no immediate funding available for a long-term solution. Sandra Hanson, EMS; Lyle Bopp, States Attorney; the Hall Township Board, and Sargent County Commissioners will cooperatively be involved with decisions on which way to legally proceed with work and funding. Lyle Bopp returned to the meeting at 3:00 p.m.

Sparky Engquist and Steve Wyum reported on this season's road projects, FEMA administrative paperwork, road restriction complaints, and purchase of new Bobcat and the sale of the used one to Scott Hansen Farms, Guelph, ND in amount of \$23,800.00. Richard Ruch of rural Cogswell met with the Commission and discussed the condition of Co. Road #5, and damages from pipeline truck hauling. Mr. Ruch also presented the Commission with checks totaling \$3,815.10 from the Cogswell Gun Club, the funds being the proceeds of the Silver Lake Fishing Tournament held in February. The money is to be used for improvements to the County Park at Silver Lake.
