Forman, North Dakota May 15, 2007

The Sargent County Board of Commissioners met at 9 a.m. with the following members present: Maurice Orn, Mike Walstead, Steve Wyum, Bill Anderson, and Jerry Waswick. Absent: none. Lyle Bopp, States Attorney, was also in attendance.

Approve May 1, 2007 minutes as corrected. (Orn/Wyum, unanimous). The April 2007 financial report was presented.

In response to a request for legal advice from the Commission, Lyle Bopp, States Attorney, advised the commissioners that a submitted bid from a vendor must either be accepted or rejected. He further advised the Commission that only Sheriff's Department expenses related to Corrections can be expended from the County Correction Centers levy, and he also reported on his review and inquiries of the NACO Prescription Drug Discount Card Program. Lyle had reviewed the commission-approved Independent Contract of Services, and will work with Sandy Hanson, Travis Paeper, and Brenda Peterson in its implementation.

Approve Gaming Site Authorization for Bison Booster Club, Milnor ND, at the North 40 Inc., 12 Main St., DeLamere, ND, and to American Legion Bullis Post 84, Lidgerwood, ND at Geneseo Bar & Café, 317 Main St., Geneseo, ND, beginning July 1, 2007 and ending June 30, 2008. (Wyum/Waswick, unanimous).

Approve Special Permit to Lauren and Brenda Sebens, Seben's Pheasant Inn, Milnor ND, to sell beer at the Edwin Erickson farm for the watercross race on June 2-3, 2007, to raise funds for the MACC in conjunction with the Milnor June Jamboree. (Wyum/Waswick, unanimous)

Approve Sunday Alcoholic Beverage Permit to Stir'Um Up Bar and Grill, Stirum, ND for a twelvemonth period. (Wyum/Waswick, unanimous).

Approve Dance Permit to Geneseo Bar and Grill, Geneseo, ND for twelve-month period upon receipt of properly submitted application. (Wyum/Waswick, unanimous).

Wendy Jacobson, Gina Hillestad, Norm Preble, Sandy Hanson, Sparky Engquist, Julie Hassebroek, and Lyle Bopp, various department heads, met to discuss the usage of the two county vehicles and how to improve the system and alleviate problems in servicing, cleaning, purchase of gas, use of calendar, and other concerns. Sandy and Sparky are to work with Auditor's office to compile and place a laminated copy of the instructions in each vehicle.

Sandy Hanson, Emergency Manager/911 Coordinator, recommended that no Emergency Declaration be made based on her road inspections and very few reports from townships of road damages.

Jean Thielman, Senior Services Project Director, and Brian Arett, Executive Director, reported on the availability and increased usage of the transportation program and meals in the Sargent/Ransom County area. They stressed the need to get the information to all residents on using the new bus and van, and the meals available to rural residents as well as those in the cities and towns.

Gina Hillestad, Treasurer/Risk Manager, reported on Pledge of Assets in the Sargent County Bank, Forman, at \$5,405,000.00 and First National Bank, Milnor, at \$2,725,000.00, and verified these pledges are adequate according to law. Motion to approve this Pledge of Assets as presented. (Walstead/Wyum, unanimous). Gina also reported she had received the Job Description requested for Shop Foreman/Head Mechanic. Sparky will be asked to review this Job Description, and make a formal recommendation, with consideration of the 2007 budget status, at June 5, 2007 meeting. Gina discussed the 2007 Market Survey compiled by Government Management Group showing Sargent County salaries are in line with other counties surveyed with exception of Social Services Director. Motion made to have the Social Services Director review the current job description for her position and write a new one which will be submitted to the Risk Manager for review by GMG. (Wyum/Waswick, unanimous) Gina also reported that the Direct Deposit of payroll checks will be implemented with the June 2007 payroll.

Motion to not grant the first 2007 contingent payroll step increase to employees based on the following factors: 1) NDPERS recently informed the county that health insurance will increase 19% on a Family Plan and 22% on a Single Plan, 2) the county gave a 3.5% COLA increase effective January 1, 2007 to all employees, 3) the General Fund balance has decreased over the past three years, 4) GMG survey on

Sargent County salaries showed a favorable review. (Waswick/Orn. Roll vote: Aye: Anderson, Waswick, Wyum, Orn, and Walstead. Nay: none.)

Meeting recessed at 12:20 p.m. for lunch.

Craig Speich, Hall Township supervisor, phoned to discuss water problems along the Wild Rice River in Sections 25, 26, and 35 in Hall Township. The county will check out the problem along with water board and township.

Merrill Engquist, Road Supervisor, discussed the May 4-5<sup>th</sup> rainfall effects on the county roads, the Alert Code 3 bridges and forms to be submitted, the new Shop Foreman/Head Mechanic job description, load limits, new Bobcat and NH tractor, and road projects. Motion to reject bid opened on March 27, 2007, for Mixing, Laying, and Drying Blacktop submitted by Bernard Mahrer Construction, Inc., Rutland, ND, and instruct Road Superintendent to consult Mahrer Construction to submit a bid quote for mixing only. (Wyum/Orn, unanimous).

Travis Paeper, Sheriff, suggested that his department carry flags in their vehicles to mark hazardous road areas immediately when seen, and notify the Road Department that these areas need attention. He also discussed policing of dances in cooperation with other counties. Jerry Waswick, Police Commissioner, and Travis are to discuss this issue with Mike Wolff, NDACO Workers Compensation Group.
