The Sargent County Board of Commissioners met in the Commissioner's Room at the Sargent County Courthouse at 9:50 a.m., following the park board meeting, with the following members present: Bill Anderson; Sherry Hosford; and, Mike Walstead. Absent were Jason Arth; and, Dave Jacobson. Also present were Lyle Bopp, State's Attorney; Tibby Hinderlie, Sargent County Teller; and, Pam Maloney, Sargent County Auditor.

Approve May 1, 2018 meeting minutes as corrected. (Hosford/Anderson, unanimous)

Amber Boeshans, ND Livestock Alliance; & Jeremy Lang, ND Department of Health; arrived at the meeting. Ms. Boeshans came to the meeting to introduce herself & to make the commissioners aware of the ND Livestock Alliance. The mission of the NDLA is to support, enhance & promote animal agriculture in North Dakota. They are hoping to host education events in the community; host on-farm and virtual farm tours to give community members an inside look at animal agriculture; & to provide information and support to local zoning boards. They are an organization hoping to provide assistance to farmers, ranchers and communities with the development or expansion of the livestock industry and to strengthen the connection with consumers to instill confidence in the practices that are used, and in the food and products produced. Mr. Lang answered questions about the permitting process through the ND Department of Health, and inspections of livestock facilities performed to ensure compliance with State Laws and Health Department regulations. Ms. Boeshans and Mr. Lang were referred to the Sargent County Extension Service office and to the Sargent County Job Development Authority (JDA) as points of contact to assist with the development of livestock production and processing businesses in Sargent County.

Pat Olofson, Sargent County Historical Society, arrived at the meeting. She presented 2017 financial statements and also reported on improvements made at the museum in 2017. She also listed projected improvements for 2018. She commented that the museum had visitors from 27 states & 5 foreign countries last year. The commission commended the members of the county historical society for the wonderful job they are doing at the museum, and for bringing visitors to Sargent County.

Jayne Pfau, Assistant State's Attorney, arrived at the meeting at 10:50 a.m.

Denise Ferderer, Tax Director arrived at the meeting along with several Gwinner City residents. Those attending were David McFarland, Keith McFarland, Linda Johnson, Jerry Waswick, Grover Riebe & Clarmont Ulven. There were several applications for abatements of taxes that needed to be addressed for the reason that the taxpayers believe the true & full value of the commercial properties were overstated by 43.7%. 1) Parcel 31-9322000 – Lots 15-16-17-18, Block 7, Original Townsite, owned by PRJ Brothers, LLC; 2) Parcel 31-9535000 - Lot 1, Block 1, Crossroads Addition, owned by Crossroads Motel, Inc; 3) Parcel 31-9804000 – Lot 11, Block 2, GCDC 2nd Addition, owned by Grover C Riebe, Jr; 4) Parcel 31-9702000 - Lot 3, Block 1, GCDC 1st Addition, owned by Keith & Pamela McFarland; 5) Parcels 31-9537001 - Lot 3, Block 1, Crossroads Addition; & 31-9295000 -Lot 8, Block 5, Original Townsite, owned by Gerald M & Tracey A Waswick; 6) Parcel 31-9508000 – 4.2 Acre Tract beg 366' S of NW corner 25-132-56; E 666'; S 366'; W 333'; N 182; W 333', owned by Ray-Mac, Inc. Mr. Waswick informed the commission that Gwinner City has asked for an attorney general's opinion regarding the authority of the State Board of Equalization to authorize and approve the increase in the commercial valuation which is alleged to be out of tolerance allowed by state law following the re-appraisal performed by the Vanguard Co. pursuant to a contract with Sargent County. After much discussion between the commissioners, tax director and the Gwinner City Residents, a motion was made to deny the applications of parcels 1-5 on the grounds that the valuations were correctly calculated in accordance with State Law, and in accordance with the rules and procedures promulgated by the North Dakota Tax Department and the State Board of Equalization; and, to reduce parcel #6's true & full value by 134,600 based upon the recommendation of the Sargent County Tax Director. (Anderson/Hosford) Upon roll call vote: Yes – Anderson, Hosford & Walstead. No – None. Absent and not voting: Arth and Jacobson. Motion carried.

Mr. Waswick requested the list of 39 residential sales from 2016 which had been used in the residential appraisal process from the tax director.

Merrill Engquist, Road Supervisor, arrived at the meeting. He has received one application to fill the road equipment operator position. He and Commission Chairman Mike Walstead will be interviewing the applicant this week, as Road Commissioner Dave Jacobson is out of town for an extended period. The new John Deere tractor and loader which has been rented from Green Iron has arrived and has been insured. The road crew will resume working on County Roads #12 & #14 once spring farm work has been completed and traffic is lighter.

The commission received a Sargent County Road Permit Application from Quandt Brothers to trench an irrigation power wire through County Road #5 ¼ mile west of the intersection of 115th Ave and County Road #5 between SE1/4 of Section 6-129-58 and NE1/4 of Section 7-129-58 (Southwest Township). The plan as described on the application was to use a trencher and place the cable 30" deep through the roadway. The Sargent County Road Permit states that the minimum depth must be 42 inches. Motion to approve the Sargent County Road Permit to the Quandt Brothers on the condition that the applicant complies with all requirements of the permit, including burying the cable a minimum of 42" deep at all points in the county's right of way. (Anderson/Hosford) Upon roll call vote, motion carried unanimously.
