Approve minutes of May 3, 2011 meeting as corrected. (Wyum/Walstead, unanimous)

Lyle Bopp, States Attorney arrived at this time.

Discussion followed on the volume of water flowing downstream from Buffalo Lake and concern about increases in the size of the existing culverts through County #1 and #10. A lengthy discussion followed on extending the existing temporary easements for the emergency drain from Buffalo Lake and the Water Board's role in supervising the permit. Lyle Bopp will draft a letter to the Water Board concerning this matter. Shuman Township will also be asked to join in any request to the State Water Commission to extend the permit for the Emergency Drain.

Travis Paeper, Sheriff, stopped in at the meeting to discuss the county fleet of vehicles for official use. The 2007 Durango formerly used by the Sheriff's Department is better equipped and a higher end version of the Durango's. It has a third seat, rear control panels and other options that the 2003 does not have. This was in the Sheriff's fleet and is now available for the county fleet. Motion to place the 2003 Durango in surplus property, to be put up for sale at the earliest opportunity, and to retain the 2005 and 2007 Durango's in the county fleet for use by county personnel for county business. (Anderson/Jacobson, unanimous)

Sandy Hanson, EMS/911/Tax Director, met with the Board and asked for time on the June 7th meeting for Keystone Pipeline officials to meet with the commissioners. On May 7th there was a crude oil release at the Ludden pumping station site in Southwest Township, and approximately 500 barrels of oil at 42 gallons per barrel were released from the pump station. The June 7th meeting will be a time to discuss the situation and also assess any potential road issues that may have been made significantly worse by the oil spill response traffic on May 7th.

FEMA officials will be in the county on June 6th to work with township, city and county personnel on the 2011 flood disaster.

Marwood Klein, Coordinator, Forman Ambulance reported to the commissioners on total runs, income received and upcoming training for drivers. Other seminars are planned during the summer for Marwood and Brian Tayer, Milnor Coordinator. Also discussed water problems in the ambulance office and proposed plans for making improvements for storage. There is still ongoing research on constructing a new building at the fairgrounds for shared use by the ambulance service and the County Fair Association.

The Board recessed at 12:00 for lunch.

The Board reconvened at 1:00.

The Board proceeded to receive and review Request for Proposals for Preliminary Engineering Services for Emergency Relief Projects on County Roads # 1 and # 14. Interstate Engineering, Inc., Wahpeton, ND, Kadrmas, Lee and Jackson, PC, Valley City, ND and Moore Engineering, Inc., West Fargo, ND were contacted for proposals. One proposal was received from Interstate Engineering, Inc. Accept the proposal. (Walstead/Anderson, unanimous)

Approve request from Gary Thornberg, Havana to allow water from tile drains installed on property located in the SW1/4-13, the W1/2-23, the N1/2NE1/4-23, and W1/2-24-129-55 (Weber Township) to drain into and run along the road ditches along County Roads # 10 and #5 from the point where said tile drain empties into the road ditch along County #10 to the point at which the road ditch along

County # 5 intersects the tributary flowing into the Wild Rice River. The amount of water from such tile drain is estimated to be approximately 6 cfs, more or less. (Wyum/Anderson, unanimous)

Gina Hillestad, Treasurer/Recorder/Clerk of Court presented results of the 2011 Market Survey Report and Recommendation prepared by Public Employment HR Consulting. Discussed the three positions that may be provided a separate pay grade to create a market adjustment of 10-12%.

The Board received a phone call from a concerned citizen on an alleged child abuse incident.

Lyle Bopp returned to the meeting at this time.

Jason Bauer and Rick Sorenson, Gwinner; and, Lynda Johnson, Forman; met with the commission regarding a requested county burial. Mr. Bauer informed the Board of a denial of a request to pay for a burial of a family member with County funds that his spouse, her brother and her sister had received from Wendy Jacobson, Social Service Director, and his intention to file an appeal to the County Social Services Board. The commissioners informed Mr. Bauer that the next Social Service Board meeting is scheduled to be held on the morning of June 2, in the Conference Room on the second floor of the Courthouse.

David L. Jacobson left at 2:50 p.m.

Sparky Engquist, road superintendent met with the Board with updates on road issues, including the need for a new motor on the 140G motor grader. The motor has been ordered. Several county roads (#3, #5, #2 & #1) are still closed in some areas due to water crossing over the top. Sparky also discussed Emergency Repair projects, proposed gravel on county roads and the proposed work on the Crete road. He also informed the Board that the new Bobcat and a tractor have been received. Sparky reported that one of the road employees is leaving the county in July or August so he would like to advertise for one full time operator and a part-time summer employee. Authorized advertisement for one full-time Assistant Supervisor/Equipment Operator; one full-time Equipment Operator III and one part-time summer Equipment Operator.

Approval has been granted to Sargent County from the ND State Land Dept. for a 6 month fill material lease in the E1/2NE1/4-25-131-55. Authorize Mike Walstead, road commissioner to execute the lease with the State Land Dept. (Anderson/Wyum, unanimous)

Frank Heitmann, Cogswell stopped at the meeting to ask for an update on the Cogswell-Brampton railroad right of way land. He is interested in purchasing the acreage that is adjacent to his land. Mr. Heitmann was informed that the disposition of the excess highway right of way is on hold until the right of way requirements for a drain from Cogswell to Drain #11 have been determined.

Approve Gaming Site Authorizations to American Legion Lawrence Milton Berg Post 38, Cogswell, ND for Galloping Goose Bar, Inc., Stirum ND beginning July 1, 2011 and ending June 30, 2012. (Anderson/Walstead, unanimous)
