The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Jason Arth, Lyle Bopp, Mark Breker, Scott Johnson and Richard Ruch. Also present was Tim Faber, Road Supervisor; and Pam Maloney, Sargent County Auditor. Lynn Kaspari, Sargent County Teller, was present through technology.

Chairman Jason Arth called the meeting to order.

The Pledge of Allegiance was recited.

Valera Hayen, County Resident, arrived at the meeting to discuss the flow of water along County Road #2 in Section 11 of Jackson Township. A second culvert was placed between Sections 11 & 12 several years ago to preserve the integrity of the county road. Most of the water now flows through that north culvert across her land & then sits there when it hits the pipeline. She stated that she had lost about thirty acres of farmland last year. The commissioner will have Damon DeVillers, Interstate Engineering, look at it when he's in the area today. Cleaning the ditches might also help resolve some of the problem.

Jayne Pfau, State's Attorney, arrived at the meeting.

Lesley Lubenow, NDSU Extension East District Director; and Melissa Seykora, NDSU Extension Ag and Natural Resources (ANR) Agent; arrived at the meeting. Ms. Lubenow stated that with Cindy Klapperich's retirement, her position with Sargent County will not be re-filled. Due to budget constraints, they have modified their criteria where a second agent will be placed within the counties. One of the criteria is population – a county must have more than four thousand residents. Sargent County falls just below that at 3862. Motion to request State's Attorney Pfau to draft letters to the NDSU Extension Service and to the local legislators voicing Sargent County's concern and displeasure. (Breker/Ruch) Upon roll call vote, motion carried unanimously.

Denise Ferderer, Tax Director, arrived at the meeting. She has stated her intent to retire effective June 30, 2022. Motion to accept Denise Ferderer's resignation as tax director. (Ruch/Johnson) Upon roll call vote, motion carried unanimously.

Ms. Ferderer is recommending that the board appoint LaJuana Hayen to her position as she has been deputy tax director since 2019, and to advertise for someone to fill Ms. Hayen's position as deputy tax director. Motion to promote LaJuana Hayen to Tax Director effective July 1, 2022. (Ruch/Johnson) Upon roll call vote, motion carried unanimously.

Motion to advertise for a deputy tax director to fill Ms. Hayen's vacated position. (Johnson/Bopp) Upon roll call vote, motion carried unanimously.

Motion to approve the agenda as presented. (Breker/Bopp) Motion carried unanimously.

Motion to approve the May 3, 2022 minutes as presented. (Johnson/Bopp) Motion carried unanimously.

Alison Toepke, Treasurer/Recorder/Clerk of Court; Jerry and June Fritzen and Pat Olofson, Sargent County Historical Society; arrived at the meeting to discuss the abandoned cemetery in Herman Township The landowner who owns the rest of the quarter was not able to attend today's meeting. Those from the Historical Society provided names of those buried in the cemetery and also pictures of headstones there. Ms. Olofson has been in contact with some family members of those buried at the cemetery. She will reach out to those she has been in contact with to see if they would be willing to help with the cleanup of the cemetery or to donate to a perpetual care fund for further care of the cemetery. The Historical Society members agreed to come back to another meeting when the landowner can be present.

Damon DeVillers, Interstate Engineering; and Tim Faber, Road Supervisor; arrived at the meeting. Mr. DeVillers had compiled a bid tabulation from the bid opening on May 3 for road projects on County Roads 3, 4, 10 & 12. Motion to accept the bids from Knife River Materials, as follows: Section 1 Base Bid – County Road 4 from ND 13 north 3 miles – \$222,147; Section 2 Base Bid – County Road 3 from approximately 500 feet west of the intersection of County Road #10 and County Road #3 in Rutland to approximately 2700 feet east of the intersection of County Road #10 and County Road #3 in Rutland - \$191,961.80; Section 3 Base Bid – County Road #10 from ND 11 south 2 miles to junction of County Road #3 in Rutland - \$558,513; & Section 4 Base Bid – County Road #12 from ND 13 south 6 miles to County Road #1 - \$1,569,729.40. (Breker/Johnson) Upon roll call vote, motion carried unanimously.

Mr. DeVillers also reported that there is 19 million dollars coming to the state for bridges. He will apply for funding for those bridges that had not been chosen the last time funding was available.

Mr. DeVillers will get quotes from those contractors working in the area for the improvement of the parking lot west of the courthouse. He will get both concrete and asphalt bids.

He was also notified that wetland delineation is needed for the cleanout east of County Road #12 past Drain #7.

Approve Gaming Site Authorization for the El Zagal Viking Patrol, Gwinner, ND for Pull Tab Dispensing Device, and Electronic Pull Tab Device, at their site at Dilly's Bar and Grill, Stirum, from July 1, 2022 through June 30, 2023. (Ruch/Bopp) Upon roll call vote, motion carried unanimously.

There are three applicants for the park board member vacancy. The commission would like them to come to the next meeting to meet them and ask some questions.

Authorize the County Auditor to request another permit from the ND Game and Fish Dept. authorizing the shooting or trapping of muskrats out of season to protect roadways experiencing road damage resulting from muskrats undermining roadbeds. (Bopp/Breker) Upon roll call vote, motion carried unanimously. Only twelve muskrat control agents are allowed per county.

Motion to approve an Application for Drainage Work within County Road Right-of-Way from ND Game and Fish Department build an approach off County Road #10 to facilitate primitive boating access and small parking area on Ole Breum Lake in Section 30-131-54 — Shuman Township. (Breker/Ruch) Upon roll call vote, motion carried unanimously.

Approve May payroll in the sum of \$219,260.48 and the following bills. (Breker/Bopp). Upon roll call vote, motion carried unanimously.
