The Sargent County Board of Commissioners met at 10:00 a.m. following the meeting of the Sargent County Park Board. The following members were present: Jerry Waswick, Mike Walstead, Steven Wyum, and Bill Anderson. Absent: David L Jacobson. Also present were: Paige Cary, of the Sargent County Teller; and, Lyle R Bopp, States Attorney.

Motion to approve the revised draft of the minutes of the June 3, 2014 meeting. (Walstead/Anderson, unanimous)

Approve Township Road Mileage Certification to the State Treasurer certifying 807.25 miles of township roads in Sargent County. (Anderson/Walstead, unanimous)

Re-appoint George Bishoff to the Sargent County School Reorganization Board for another three year term. (Anderson/Walstead, unanimous)

Lyle Bopp, States Attorney, handed out a draft Gravel Purchase and Stockpile Agreement for use in removing gravel from the county owned stockpiles. He will revise the language to show a 5% rather than a 10% retainage.

Brian Tayer and Marwood Klein, Sargent County Ambulance Coordinators; and Sandy Hanson, all members of the Sargent County EMS Advisory Board arrived at the meeting. Brian Tayer provided history on the ambulance service from 1997 to present. Brian then presented a staffing proposal as prepared by the Advisory Board, outlining the recommendation to supplement the Forman Squad and Milnor Squad with 2 full time EMT positions. The purpose of the proposal is to address the current shortage of EMT's in the Forman Squad and to provide for the longer term stability and readiness of the County's Ambulance Service. Marwood Klein explained how the Forman Squad schedules the shifts in 12 hour increments. Further discussion followed on funding options for additional employees to fill these new proposed positions. Both Marwood and Brian indicated that some of the money allocated from the Emergency Medical Service levy would be freed up from the squads if the county pays for two new employees so the overall cost increase would not be as great. Total cost now for the current coordinators including salary and benefits is \$114,331.00/year and this number would nearly double with two new Emergency Medical Technicians added to the staff. A \$60,000 grant for staffing has been requested but the ambulance squads will not find out until July if it has been approved. The recommendation of the EMS Advisory Board is for the Forman Squad to hire a part time temporary EMT immediately to fill the short-term needs and pay for that person out of the squad's funds at \$100 per shift plus a per diem for meals, mileage to and from home and room at the local hotel if needed; the Forman Squad to advertise, interview and hire a permanent full time EMT as soon as possible, as a county employee; and, in 2015 budget for an additional full time EMT, also to be a County employee, for the Milnor Squad. Motion that the recommendation of the EMS Advisory Board be implemented. (Anderson/Walstead. Roll Call. Aye: Anderson, Walstead, Waswick and Wyum. Nay: None. Absent and not voting: Jacobson. Motion carried)

Wendy Jacobson, Sargent County Social Service Director, met with the Board to ask permission to amend the current agreement between Sargent County and Sioux County for supervising Eligibility Workers. The current agreement is on an emergency basis up to \$200 per month. Ms. Jacobson is requesting an amendment to change to 100 hours per month at \$20.00/hour to manage the Sargent County Eligibility Workers client caseload until a new employee is hired and trained in Sargent County. Approve request from Ms. Jacobson. (Anderson/Waswick, unanimous)

The meeting recessed at 12:30 for lunch.

The meeting reconvened at 1:40 p.m. for a Preconstruction Conference for BRC 4120(055) – Bridge 123-20.0 (aka Hoistad Bridge) replacement project on County # 5. Damon DeVillers, Interstate Engineering, Inc. asked for introduction of those in attendance and proceeded to discuss the project and acquire the necessary information. The project is scheduled to begin around July 17 and be completed by September 15, 2014.

Sparky Engquist, Road Supt. reported that on June 9<sup>th</sup> the road restrictions had been lifted. He handed out tentative maps for 2014 gravel projects; reported that the new maintainers should be delivered in the next few weeks; and, reported that Paul Shearer, new road department employee had begun working for the Road Department on June 16<sup>th</sup>. Sparky reviewed the County Road Right of Way application filed by Edwin Erickson Jr. and Terry Erickson, Milnor. Said request is to clean the ditch, install a driveway and lower the level of the slough with a pumping station along County Road No. 1 between Section 7 and 8 and Section 17 and 18 of Shuman Township. Motion to approve the application provided pump is not located in the county road right-of-way and erosion control is installed at the outlet of the pipe. (Walstead/Waswick, unanimous)

Travis Paeper, Sheriff met with the Board to request permission to submit a new Comprehensive Position Questionnaire (CPQ) to the county pay plan personnel to redo the job description for the Chief Deputy. Sheriff Paeper has appointed Brenda Peterson, current Deputy Matron, to that position and due to a change in duties, he is requesting an update on the job description. Motion to approve the submission. (Waswick/Walstead, unanimous)

The Board reviewed the results of the Official Canvass of the June 10, 2014 Primary Election. Approve certification as follows on county offices: County Commissioner at Large: Steven Wyum-441, Richard Ruch-402, David L Jacobson-471; Sherry Hosford-673; and, Mike Walstead-528; County Auditor – Pam Maloney-845; County State's Attorney –Lyle R Bopp – 746; County Treasurer/Recorder/Clerk of District Court – Gina Hillestad – 826; County Sheriff – Travis A Paeper – 790; Official Newspaper – The Sargent County Teller - 739 (Anderson/Walstead, unanimous)
