The Sargent County Board of Commissioners met at 10:00 a.m. following the Sargent County Park Board meeting. The following members were present: David Jacobson, Sherry Hosford, Mike Walstead, and Bill Anderson. Also present was Lyle Bopp, State's Attorney; Jayne Pfau, Assistant State's Attorney; Paige Cary, The Sargent County Teller; and Pam Maloney, Sargent County Auditor. Absent: Commission Chairman Jerry Waswick. In the absence of Chairman Waswick, Commission Vice-Chairman Bill Anderson served as Chairperson of the meeting.

Jesse Mastenbrook, Sargent County Insurance Agent, arrived at the meeting. He reported that he and the county auditor are working on updating the information for the insurance renewal due in July. He presented claim information from 2015 and also for the current year. The commissioners thanked him for the report, & requested that he attend annually to update the Commission on insurance information and claims.

Donna Eklund, county resident, arrived at the meeting.

Merrill Engquist, Road Supervisor; and Damon DeVillers, County Engineer, Interstate Engineering; arrived at the meeting. Mr. Engquist informed the board that the Road Department's 2003 GMC pickup has been damaged in a deer/vehicle collision. The adjustor believes that the repair estimate is likely to exceed the book value of the pickup, and that it will be totaled out. Mr. Engquist proposes that the Road Department buy back the salvage title, repair the pickup & continue using it.

Mr. Engquist reported that the North Dakota Game & Fish Department had approached him regarding the access road to Alkali Lake. There is money available to do some grading and graveling. The county would hire and pay a contractor to come in & do the work and then be reimbursed from the Game & Fish Department. On the basis of the information provided, the commissioners have no opposition to this, but would need a contract stating that the county would be reimbursed for all funds expended. Additionally, as other projects of a similar nature, at Buffalo Lake and at Kraft Lake, have been coordinated by the County Park Board, it was suggested that the information be forwarded to the Park Board for consideration at the July meeting. Mr. Engquist also reported that he had been informed of grant monies available for replacement of old and damaged docks. The commissioners requested that the auditor put this matter on the park board's July agenda.

Mr. Engquist stated that County Road #14 is almost ready for Mark Sand and Gravel to come in & do the road paving project. There is slope work yet to be done, with dirt to be hauled in for that purpose, & extensions put on some culverts. Mark Sand & Gravel was planning to start the County #14 paving work on Monday, June 20, but was delayed by rain in Minnesota and is now planning to start work on the project either next week or in the week after the 4<sup>th</sup> of July.

The graveling projects in the county have been started, but there is some concern about black dirt in one of the gravel stockpiles that one contractor may have applied to one stretch of County Road. Mr. DeVillers is planning to check on this stockpile after the meeting today.

The commissioners asked if County Road #14 north of Geneseo has been maintained as was discussed at the June 7 commission meeting. Mr. Engquist said that when the Road Crew is done preparing County Road #14 south of Geneseo for the paving project, they will be ready to address the road problems on County #14 north of Geneseo.

Mr. Engquist also stated that the Road Department employees are replacing the faded out road signs as time allows.

Mr. DeVillers recommended the commission accept Mayo Construction's bid for the Milling, Hot Bituminous pavement preservation Overlay & Incidentals of Sargent County #4 from ND/SD border north to Sargent County #5 (4 miles), as they had the low bid of \$684,362.00. Some discussion was held whether or not to accept the base bid along with the alternative of a seal coat. Motion to accept the base bid from Mayo Construction contingent upon determining whether or not remaining CNOA project funds from 2014 and 2015 could be used (Walstead/Hosford) Roll Call Vote: Yes – Anderson, Jacobson, Walstead, and Hosford. No – None. Absent – Jerry Waswick. Motion carried.

Meeting recessed for lunch at 12:15 p.m.

Meeting reconvened at 1:20 p.m.

Lyle Bopp presented a revised "Application for Drainage Work within County Road Right-of-Way" form for the commissioners to review. After review and discussion, it was decided to add "No work under this application is to be started until the application is approved and the permit is issued" in bold letters on the front of the form. Motion to approve the form with the revision. (Hosford/Jacobson, unanimous)

Discussion on the Silver Lake Dam Embankment Seepage Investigation Report received from the North Dakota State Water Commission. It was decided to wait & see what happens after the NRSCS interns clean out the willows and other vegetation in the area of the leak to obtain more complete information about the problems causing the seep.

More discussion was held on the ND Public Employees' Retirement System (PERS) Retirement program. The auditor was instructed to prepare a spreadsheet to see how much money it would cost the county with the 1.26% increase in the County's contribution to PERS that enrollment in the State retirement system would require. The board will review this at the next meeting.

Commissioner Walstead reported on the Hwy/Rail Crossing Diagnostic that had been requested by Sargent County and the City of Rutland. He stated that an inspection group consisting of himself, Mr. Jim Styron of the ND DOT and 2 representatives of the DMV&W Railroad had started in Havana and worked their way to the northeast, along the line owned by the South Dakota Rail Authority checking each County Road rail crossing as they came. Mr. Styron will write a report on each of the 6 County Road rail crossings, as he agrees there should be some crossing safety improvements at the crossings in Havana and Rutland. There is no Federal or State cost sharing money available for crossing safety improvements at this time, but there will be a 10% county cost share responsibility when there is Federal or State money available for crossing improvements.

States Attorney Bopp reported that there has been no determination received in the Jacobson unemployment compensation appeal since the telephone hearing held on June 9<sup>th</sup>.

More discussion was held on the field approach that appears to be a possible hazard in the county road right-of-way north of Brampton. The State's Attorney is still checking right-of-way in this area to determine if the county has jurisdiction and authority to require the landowner to correct the problem. He has also discussed the situation with the resident who reported the potentially dangerous condition of the approach.

Two applications were received: from Terry Euscher, Gwinner; and, from Nancy Glarum, Rutland; agreeing to accept re-appointment to the County School Re-Organization Board. Motion to re-appoint Terry Euscher and Nancy Glarum to the County School Re-Organization Board with terms ending June 30, 2019. (Hosford/Jacobson, unanimous)

Two applications were received: from Janet Kiefer, Cayuga; and, from Joanne Anderson, Havana; for appointment to the Social Service Board. Motion to re-appoint Janet Kiefer to the Social Service Board with term ending June 20, 2019. (Jacobson/Walstead, unanimous)

Motion to authorize the chairman and the state's attorney to sign the County Federal Aid Contract and the County Federal Aid Contract Bond with Gladen Construction for Project BRO-0041(012) (Hall Township Bridge Project). (Walstead/Jacobson, unanimous)

Commissioner Hosford reported that Sheriff Paeper has submitted a COPS grant for an additional officer. He will be adding this to his 2017 budget and will know mid-September if he has received the funding. This would be an additional cost of approximately \$49,000 for the county, spread out over three years. The fourth year, the county would assume all costs for an additional officer.

Commissioner Hosford also encouraged the board to attend a public comment meeting regarding a proposed study of the Shortfoot Creek Watershed area to be held in Geneseo on June 28 at 1:30 p.m. as future plans, or the lack of plans, for the management of this watershed area could affect County Roads in the area, including portions of the recently paved stretch of County Road #14.

Acknowledged receipt of the complaints filed by Wendy Jacobson with the North Dakota Department of Labor and Equal Employment Opportunity Commission (EEOC). State's Attorney Bopp stated that the County has 20 days to file a response, and that he and assistant Jayne Pfau have been working on it.
