The Sargent County Board of Commissioners met at 9:00 a.m. with the following members present: Mike Walstead, David L Jacobson, Jerry Waswick, Bill Anderson and Steve Wyum. Absent: None. Paige Cary, the Sargent County Teller was also present.

Wendy Jacobson, Director, Sargent County Social Services and Clara Rebel, Social Worker met with the Board to discuss the Adult Protective Services Program. This program has been administered for the Counties in southeastern North Dakota by Cass County Social Services, without charge, until the end of this year. Wendy presented a brief history of Adult Protective Services in North Dakota as well as case loads of the counties served by Cass County. Staff from Cass County is well trained and experienced in getting into the homes in which adult protective services are needed and in providing the needed services. Clara Rebel is the county coordinator. Cass County Social Services will no longer be providing services without charge. As budget time approaches there are options that have been presented and Wendy asked for input from the county commission. She feels that the involvement of Sargent County is very important to the aging population in the county. Following discussion the commission agreed that Wendy should pursue the Allocation of Regional Adult Protection Social Worker program. Costs to Sargent County as estimated at \$4,068 for 2012 and \$4,375 for 2013.

Lyle Bopp, States Attorney arrived at the meeting at 10:00 a.m.

Mark Gainor, Milnor Airport Authority, met with the commission and updated the Board on the Milnor Airport. He reported that the ND Aeronautics Commission had approved a grant for the Milnor Airport Authority in the amount of \$25,000 as partial funding to prepare the site and erect a hangar with a concrete floor. This amount falls short of the amount for the entire project, which is estimated to be \$63,000. Mr. Gainor said they have \$12,000 in their building fund and another \$6,000-\$7,000 for 2012. The three year contract with Sargent County and the Milnor Airport Authority will expire in 2012 and he would like some reassurance that this contract will be renewed to allow for more matching monies to construct the hangar. After further discussion the Board instructed States Attorney Lyle Bopp to draft a renewal of the contract that includes language automatically renewing the contract unless both parties consent to its termination or expiration; or, it is terminated by operation of law.

Bruce Speich, Milnor, arrived at the meeting to discuss the condition of roadways in northeastern Sargent County. Roger Brekke, Milnor also was in attendance. Mr. Speich commented on several County roads that he thinks need immediate attention. He offered to pay \$1250 to help pay Larry Bohnenkamp to blade County Road #14 from ND 13 6 miles south to County 1 if the county will match that amount. He is also concerned about the quality of the gravel being applied to some County roads. Road Superintendent Sparky Engquist arrived at the meeting and reported that the gravel that is being stockpiled now is Class 13 with some clay binder. Sparky is of the opinion that the gravel being applied to County roads meets the specifications that are required in the county bid. A lengthy discussion followed on work ethics and training for road department employees.

Damon DeVillers, Interstate Engineering, Inc. and Bill and Jerry Woytassek arrived at the meeting. Damon informed the Board that he is waiting for the archeological report on Bridge 123-20 (Hoistad bridge) before the replacement option is recommended to the Commission and selected. Damon also reviewed the projects for Emergency and Permanent Repairs and requested that any expenses from the county for these sites be prepared for submission to the state for reimbursement. Sparky informed the Board that he has the expense statements from those sites prepared for submission.

Steve Wyum reported that addressing Jerry Woytassek's access problems to and from his home at Buffalo Lake is still waiting for final approval from the Federal Highway Administration and NDDOT. According to Jerry, the water has now equalized on both sides of his driveway. Sparky suggested raising this roadway 3-4 feet to prevent Buffalo Lake water from backing up and inundating the roadway. Jerry and Bill Woytassek also discussed an issue with the water through Bill Woytassek's yard off the county road east of Rutland. Sparky has looked at this site and, if the road ditch on the north side of #3 needs to be cleaned to allow the water to flow to the east, he will check with NRCS for elevations.

Another road issue was the uninstalled culverts south of Rutland that was rolled through a corn field by the July 10th wind, causing damage to a corn field owned by Larry Erickson. Sparky was instructed to remove all of these culverts to a secure location, as soon as possible. Time cards for Jamey Lien, Assistant Road Supervisor were also discussed, regarding questions about the amount of sick leave use during the month of May and June. Mr. Lien had informed the Commission at about that time of his plans to leave the employment of Sargent County in July or August. The Board requested that States Attorney Lyle Bopp contact Mr. Lien to obtain a physician's statement concerning the condition that

required the use of the sick leave; and, to work with the commission chairman and road commissioner to determine the hours of pay to which Mr. Lien may be entitled in an August pay check.

The Board recessed at 12:25 p.m. for lunch.

The Board reconvened at 1:15 p.m. with Travis Paeper, Sheriff, Richard Ruch, Cogswell and Sparky Engquist, road supervisor present.

Travis Paeper explained a bill for travel for Deputy Rick Bryant regarding travel to return from Guard duty to work the Gwinner City street dance. Board approved an amended payment of the \$68.85.

Discussed the 2007 Dodge Durango, which is part of the county fleet, and which had been having problems with warning lights appearing on the dash for no apparent reason. McLaen's Service, Rutland has checked out the vehicle and the problem has not yet been resolved. A new battery was placed in the vehicle but the problem still persists. A bill for \$473.71 for service and repairs to the 2007 Durango has been submitted for payment from McLaen's Service. Motion to split the bill 50/50 between the Sheriff's Dept. budget and the County Car budget. (Jacobson/Anderson, unanimous)

A letter from Dunbar Township was received and read concerning the Township's concerns about the water that is coming through the culvert one-half mile north of Forman. Dunbar Township roads are being flooded and washed out, already and Forman City wants a bigger culvert through Highway #32 north of Forman that would allow even more water to pour through during periods of high rainfall and runoff. The township cannot handle the water it is getting now without more culverts; therefore Dunbar Township is against placing any more culverts through the highway unless the additional problems created downstream are also addressed at the same time. A copy of said letter was forwarded to Kevin Gorder, Fargo District, NDDOT and to Forman City.

Joseph Breker, Havana has submitted application for Property Tax Incentives for New or Expanding Businesses for "Coteau Des Prairie Lodge LLC" located in (NW1/4ofSE1/4-9-129-54 LTL) 9953 141st Ave SE, Rutland for a 40 foot by 88 foot lodge of log and wood construction, finished product to be refined but rustic. Mr. Breker is requesting 5 years of 100% property tax exemptions for the value of the improvements and an additional 5 years of Payments in Lieu of Taxes. A hearing on said application was scheduled for 9:00 a.m. on Tuesday, August 2, 2011 in the Commission Room of the Sargent County Courthouse, Forman, ND.
