Approve minutes of August 2, 2011 meeting as corrected and July financial statement. (Wyum/ Walstead, unanimous)

Reviewed unfinished business items. The Board received and reviewed the building insurance policy and contents with State Fire and Tornado and recommended no changes to the current coverage.

Discussed renewing the Emergency Drainage permit # 3523 and recommended review prior to the September 6, 2011 meeting.

A resolution regarding increased appropriation and an advance allocation of the April 2012 Road Distribution to the non-oil counties was reviewed and a motion to approve the resolution as voted on at the Southeast County Commissioners Association quarterly meeting in Forbes, ND on July 7th. (Wyum/Walstead, unanimous)

The City of Milnor approved cancellation of costs associated with the 2007 originally published and certified Final Special Assessment list for the City of Milnor Street Improvement District No. 01-06. Milnor City made adjustments to correct a clerical error made at the time of the assessments. Milnor City requests that the County not assess any additional costs than the special assessments that were to have been originally placed on Parcel 25-7720000 and have now been correctly placed on that property and removed from Parcel 25-7720002, that being the true and correct assessment of each property, as determined by the Special Assessment Commission to the best of their judgment. Motion to concur with Milnor City on correcting the special assessment penalty and interest. (Wyum/Walstead, unanimous)

Lyle Bopp, States Attorney arrived at this time.

Approve Pledge of Assets as presented by Gina Hillestad, Treasurer/Recorder/Clerk of Court, showing \$2,625,000 at First National Bank, Milnor, and \$5,877,385 at Sargent County Bank, Forman ND, which is adequate for July 2011. (Wyum/Jacobson, unanimous)

Approve Games of Chance Permit # 2011-02 to Cogswell Gun Club, Cogswell, ND for a raffle on September 11, 2011 at Cogswell Gun Club Trap Grounds, Cogswell, ND. (Walstead/Jacobson, unanimous)

Gina Hillestad, member of the Personnel Board presented the 2011 Market Survey Report and Recommendation by Public Employment HR Consulting.

The Personnel Board recommended an annual Cost of Living Adjustment (COLA) for 2012. Based on the Consumer Price Index of 3.9% and Employment Cost Index of 1.2%, the recommendation is for a 2.6% COLA.

A meeting of County officials with membership in the North Dakota Association of Counties (NDACo) was called for the purpose of selecting a delegate and alternate to represent Sargent County

at conventions of the Association from October 1, 2011 to September 30, 2013. The County Commissioners and Sherry Hosford, Auditor; Gina Hillestad, Treasurer/Recorder/Clerk of Court; and Lyle Bopp, States Attorney were all present and are all County Officials granted membership in the NDACo. Other county officials that are members of NDACo and not present were the Sheriff, Social Service Director, and Tax Director. Sherry Hosford nominated Gina Hillestad as Delegate and Mike Walstead as Alternate. Mike Walstead seconded the motion. Motion carried. Ms. Hillestad and Mr. Walstead will serve a two-year term as the NDACo Delegate/Alternate for Sargent County.

The Board recessed for lunch.

The Board reconvened at 1:00.

Sparky Engquist, road supervisor and Damon DeVillers, Interstate Engineering, Inc. met with the Board and presented an update on Emergency Repair projects and funding. Discussed the road project by Kraft Slough and approved proceeding with the project when funding is secured. Damon, Sparky and road commissioner Mike Walstead were authorized to concur with each other on project information. (Wyum/Jacobson, unanimous)

County No. 4 project, which was bid earlier this year and rejected for excessive pricing to microsurface the roadway, was discussed. Mr. DeVillers feels the oil prices are going to drop and also in November the contractors will be looking to line up work for the next year. Instructed Damon DeVillers, Engineer to submit the project to the state for rebid in November 2011.

Richard Ruch, Cogswell arrived at the meeting to discus the roadway out to the pipeline pumping station. He informed the Board that the company will be building up a dike around the site which will require transporting many truckloads of dirt out of the area. Sparky Engquist will contact the pipeline contractors to inquire about using the dirt to building up the county road.

The Board proceeded to work on the 2012 budget. Travis Paeper, Sheriff, met to explain specific line items on his budgets and discussed vehicle purchase for his department and trade-in versus county fleet.

Motion to approve a COLA contingency for 2012 salaries equal to 2.6%, the amount recommended by the SC Personnel Board. (Wyum/Walstead, unanimous)

Discussed a longevity plan for county employees. No action.

Motion to approve an additional \$32,000 for salary contingency in the 2012 budget. (Jacobson/Wyum, unanimous)
