The Sargent County Board of Commissioners met at 10:00 a.m. after the park board meeting with the following members present: Jerry Waswick, David Jacobson, Sherry Hosford, Mike Walstead, and Bill Anderson. Also present was Tibby Hinderlie & Paige Cary, The Sargent County Teller; and Pam Maloney, Sargent County Auditor.

Jon Hanna, Veteran's Service Officer, arrived at the meeting. He reported that he currently has about 75 veterans that he is serving in Sargent County. He also works with veterans in Ransom County and at the North Dakota State Veterans Home in Lisbon. He works with different grant programs, death benefits/pensions, service connected disabilities, Agent Orange & PTSD. He reported that there are loans available for those in need of services also. The commissioners thanked Mr. Hanna for his energy, enthusiasm and his commitment to the veterans of Sargent County.

Jayne Pfau, Assistant State's Attorney, arrived at the meeting at 10:30 a.m.

Sandra Hanson, Tax Director/911 Coordinator/Emergency Manager; arrived at the meeting. She reported that Vanguard Appraisals would be starting the commercial reappraisals next week. Letters have been sent out to the larger businesses to better facilitate the reappraisal process. She also reported that the FEMA auditors are here this week auditing the 2011 FEMA disaster.

Discussion on the maintenance of the Health Department building emergency auxiliary generator. It was decided to ask Darwin Fliehs of Forman Repair if he will check it twice a year and service it when needed. Forman Repair is right next door to the Health Department Building, and Mr. Fliehs already monitors the generator's weekly test starts on a volunteer basis.

The front windows of the Health Department building have been leaking during thunderstorms and there is considerable draft in the winter time. The windows are original, and the window frames and casings appear to have deteriorated over time. Commissioner Hosford will get estimates on replacing the two front windows. The courthouse custodian, Joe Butler, will be contacted to fix up the leaks as best he can until the windows can be replaced.

Discussion on the Health Department Administrator position. A current county employee has been offered the job and, according to county policy, she will retain her years of longevity with the county in her new position. She will transfer her vacation and sick leave hours with her, but it was suggested that a check be cut from the county general fund to the health department to cover the vacation liability. The Auditor will check to make sure that correct procedure is followed.

Travis Paeper, Sheriff, arrived at the meeting. He informed the board that Brenda Peterson, Chief Deputy, has accepted the health District administrator position, so he will be hiring a person to fill her position. He also stated that the 911 duties that Ms. Peterson has been doing would revert back to the 911 Coordinator and that the sheriff's office would no longer be able to do motor vehicle work, assisting people with motor vehicle title, registration and licensing issues.

Virgil Nogowski, Assistant Road Supervisor, arrived at the meeting. He reported that the graveling projects are nearing completion; they would be working on the soft spots on #12 & #14 next week; #14 south of Geneseo has been chipped; and that he is continuing to order and replace signs as time and finances allow. There was also discussion about retaining the Cat motor grader, and establishing a schedule for replacing trucks in future years.

The location of the culvert in the field approach north of Brampton has been measured and it has been determined that it is in the county road right-of-way, and therefore, the county's responsibility. The road crew will be notified to put extensions on the culvert and properly slope the sides of the approach.

Motion to appoint Nancy Planteen, Forman to the Planning Commission. Term ending June 14, 2019. (Walstead/Jacobson, unanimous)

Jayne Pfau reported that she had done further research on the Jacobson unemployment compensation appeal and, in her opinion, it would not be worth appealing to the district court. She also reported that the reply to the Schwab unemployment compensation claim will be sent this week.

Some discussion on the organic materials in the county's gravel stockpile. Commissioner Waswick had discussed the matter with the contractor, and the contractor's position is that the gravel in the stockpile met County gravel specifications. County gravel specifications provide that deleterious material, including black dirt and organic material, is not acceptable. Tests results from an independent testing lab indicate

that black dirt and organic materials are present in substantial quantities in the stockpile in question. No action was taken at this time.

Approve form for use by those employees requesting time off from work for vacation, sick leave, personal leave or bereavement leave pursuant to the Sargent County Personnel Policy Section 306. The form is to be signed by both the employee and by the employee's supervisor. (Jacobson/Anderson, unanimous)

More discussion was held on whether signage is available to reflect that wheelchair access is only available at the west entrance to the Courthouse. The auditor has done some research, but will get price quotes and contact the Freedom Resource Center for more information about recommended wording for new signs.
