The Sargent County Board of Commissioners met at 9:10 a.m. in the Commissioner's Room with the following members present: Bill Anderson; Jason Arth; Lyle Bopp; Richard Ruch; and, Jerry Waswick. Absent – none. Also present was Joe Butler, Custodian; Wendy Willprecht, Emergency Manager/911 Coordinator; Jayne Pfau, State's Attorney; Jeanne Sexton-Brown, Sargent County Teller; and Pam Maloney, Sargent County Auditor.

The Pledge of Allegiance was recited.

Ms. Willprecht & Mr. Butler were present to discuss the water seepage in the Emergency Manager's office in the basement. The carpet has been ripped out & disinfectant applied to the floor. Water also leaks into the custodian's office, as well. The surfaces of some walls are deteriorating in other areas of the Courthouse basement, too. It was decided that Commissioner Bopp look into finding a company to provide an estimate on repairs and also to look into possible tiling around the east and north sides of the courthouse.

Ms. Willprecht also requested that the commission approve the Hazardous Materials Response Plan renewal that she had submitted for consideration. Motion to approve the Hazardous Materials Response Plan as presented by Ms. Willprecht. (Waswick/Anderson) Upon roll call vote, motion carried unanimously.

Carol Peterson, Milnor City Economic Development Director, arrived at the meeting. She was here to discuss Census 2020 and the importance of having a complete count in all communities. She is requesting that the following resolution be adopted:

SARGENT COUNTY RESOLUTION

RESOLUTION ESTABLISHING SARGENT COUNTY COMPLETE COUNT COMMITTEE FOR 2020 CENSUS

WHEREAS, the Constitution of the United States of America requires an enumeration, or "census," of the population every 10 years; and

WHEREAS, the next decennial census of the population will be taken on April 1, 2020; and

WHEREAS, the decennial census data compiled in the 2020 Census will be used to determine the apportionment of seats in the State Legislature and the allocation of billions of dollars of federal, state and county funds for social and other programs for the next decade until the next decennial census is taken; and

WHEREAS, it is vitally important that every person in Sargent County, North Dakota, is counted in the 2020 Census; and

WHEREAS, Sargent County, North Dakota, will establish a Complete Count Committee that will develop and implement an awareness campaign that motivates residents to respond to the 2020 Census and encourages participation by population groups that are often undercounted; and

WHEREAS, the County Auditor will have full authority to appoint government and community leaders to serve as members of the Complete Count Committee and to partner with the U.S. Census Bureau to provide training to the members of the Complete Count Committee;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Sargent County, North Dakota, as follows:

1. The Sargent County Complete Count Committee is hereby established to develop and implement an awareness campaign that motivates residents to respond to the 2020 Census and encourages participation by population groups that are often undercounted; and

- 2. The County Auditor of Sargent County, North Dakota, is hereby authorized to appoint government and community leaders to serve as members of the Sargent County Complete Count Committee, to partner with the U.S. Census Bureau to provide training to the members of the Sargent County Complete Count Committee, and to take all steps necessary to accomplish these purposes.
- 3. This Resolution shall go into effect upon approval and passage by the Board of Commissioners.

Commissioner Anderson introduced the foregoing Resolution and moved for its adoption. The motion was duly seconded by Commissioner Bopp. Upon vote being taken thereon, the following Commissioners voted "AYE": Anderson, Arth, Bopp, Ruch and Waswick; and the following Commissioners voted "NAY": None. Absent and not voting: None. Motion carried and resolution adopted.

Ms. Peterson also stated that there will be a meeting on Wednesday, November 6th at 5:30 pm at the Gwinner Community Center to organize and have a 1 to 2 hour training session on Census 2020.

Approve September 3, 2019 meeting minutes as corrected. (Bopp/Waswick, unanimous)

The auditor requested authorization to add the new deputy auditor, Heidi Johnson, to the signature card at the bank. Motion to authorize Heidi Johnson, Deputy Auditor, to sign signature cards at the local financial institutions to enable her to sign warrants for payment of bills; and, to remove the name of April Bladow, former Auditor deputy from the signature cards. (Anderson/Waswick, unanimous)

The custodian had provided a quote for a new snow blower. Action was tabled pending receipt of additional information.

The wheelchair accessible door on the west side of the courthouse has not been working for some time and has been inspected by House of Glass, Aberdeen, SD. The mechanism is not repairable, and a quote in the amount of \$2,676 to purchase and install a new opener mechanism was received from House of Glass, Aberdeen. Motion to accept the quote and move forward with installing the new mechanism. (Bopp/Anderson) Upon roll call vote, motion carried unanimously.

It was brought to the attention of the board that there is a piece of Rosemeade pottery in one of the display cases in the basement. There is someone interested in purchasing it. Motion to offer it to the Sargent County Museum for display purposes, only, and if the museum has no interest, it will be offered for sale on bids. (Waswick/Bopp) Upon roll call vote, motion carried unanimously.

Discussion was held on a property in Cogswell which was forfeited to the county for delinquent taxes last November. There is an abandoned church building on the property. The State's Attorney was requested to provide an opinion as to whether the county is legally obligated to obtain ownership of these properties during the Delinquent Tax Forfeiture proceedings.

The commissioners agreed to put a link on the county's website to Senior Living Help, which is an organization that provides senior living assistance to the elderly.

A letter of resignation was received from Stephanie Rufsvold, Deputy Tax Director. Motion to accept the resignation, with regret. (Waswick/Anderson) Upon roll call vote, motion carried unanimously. An exit interview will be provided to Ms. Rufsvold.

Commissioners Arth, Ruch and Waswick, presented a concise report on the Washington DC White House Conference that they had attended on September 10. Commissioner Waswick reported that all of the Federal officials seemed to be receptive to the input received from the county commissioners in attendance. He also stated that the National Association of Counties is well respected and has a very strong presence in Washington.

Congratulations were extended to Bill Anderson, for being selected to receive the NDACO 2019 Excellence in County Government Award in the County Commissioner Category. Commissioner Anderson will be presented with the award at the NDACO Conference in October.

Commissioner Bopp reported that the elements have finally been ordered for the heating system, but have not yet been received.

Commissioner Bopp also reported that he had conferred with Richland County and that he had received a job description for a Human Resources Director. He will be meeting with Commissioner Steve Dick in Ransom County soon to draft a Joint Powers Agreement between the two counties. It is the intention that the position be in place by January 1, 2020.

Merrill Engquist, Road Supervisor; & Damon DeVillers, Interstate Engineering; arrived at the meeting. There was discussion on Federal Aid Projects scheduled for 2020 and beyond. Projects mentioned were the north six miles of County Road #12; six miles of County Road #12 south of Cayuga beginning at County Road #3; County #14 from ND Highway #11 to ND Highway #13; and County Road #1 between ND Hwy 32 and County Road #10; the 3 miles of County Road 10A; and two miles of County Road #10 from County Road #1 south. Bridge 122-23.0 on County Road #7, aka the Anderson Bridge, was also added to the list of possible projects. Mr. DeVillers will help the auditor fill out the Federal Aid Program Sheet in preparation for the meeting between ND DOT and the county at the October NDACO conference.

Some of the commissioners and the road supervisor will be attending the Sargent County Water Resource Board meeting on Thursday, September 19 at 9:30 a.m. to discuss a potential surface drainage project near Brampton. This meeting is being held to gather information on the existing drainage issues in the area and to discuss potential improvements.

Motion to retain Interstate Engineering to prepare plans and specifications for a parking lot expansion at the courthouse, after which the county shall advertise for quotes and get the project moving forward. (Anderson/Waswick) Upon roll call vote, motion carried unanimously. Mr. DeVillers was also given a listing of concerns and suggestions from courthouse employees regarding the project and was requested to include them, as much as possible, in the project's plans and specifications.

Commissioner Bopp provided the commission with quotes for grinding the stumps left behind after the tree removal process last month. Kurt Breker provided a quote of \$40-\$50 a stump, but is unable to haul away the wood chips as his truck is unavailable at this time. Mark Bopp provided a quote of 40 cents per inch of circumference. Commissioner Bopp will make a determination & get the project completed.

Motion to finance the lease/purchase of the Caterpillar 140M Motor Grader aquired from Butler Machinery through SCB Public Finance with a seven year financing option with a yearly payment of \$40,000. (Waswick/Ruch) Upon roll call vote, motion carried unanimously.

Approve September payroll in the sum of \$219,508.16 (Nos. 16807-16867 & 79370-79379) and the following bills: (Anderson/Waswick) Upon roll call vote, motion carried unanimously.
