The Sargent County Board of Commissioners met in the Commissioner's Room at the Sargent County Courthouse at 10:30 a.m. with the following members present: Dave Jacobson, Jason Arth, Mike Walstead, Sherry Hosford, and Bill Anderson. Also present was Lyle Bopp, State's Attorney; Tibby Hinderlie, the Sargent County Teller; and, Pam Maloney, Sargent County Auditor.

Approve September 5, 2017 meeting minutes as corrected. (Hosford/Arth, unanimous)

The commission received a letter from Chris Mathias regarding the "Application for Drainage Work within County Road Right-Of-Way" that had been approved at the September 5 meeting. He has requested reconsideration to allow Alternative 1 rather than Alternative 2, which had been recommended by the engineer who performed the hydraulic study. He also requested cost share for the culvert. The Commission reviewed communication from Damon DeVillers, Interstate Engineering, stating that he had reviewed the hydraulic study, and that, in his opinion, either Alternative 1 or Alternative 2 would work equally well. Motion was made to amend the previous approval to authorize either alternative, at the applicant's discretion, and to cost share 1/3 of the culvert cost. (Anderson/Walstead) Upon roll call vote, motion carried unanimously.

Motion to appoint Darci Weber to the combined position of Social Worker/Social Services Director 1 effective September 1, 2017 at Grade 14/Step 10 moving up to Grade 14/Step 11 January 1, 2018 as authorized and recommended by the Sargent County Social Services Board at its meeting on September 5, 2017. (Anderson/Hosford) Upon roll call vote, motion carried unanimously.

Motion to purchase a Vermeer M7040 Mower for use by the County Road Department from Northside Equipment, Lidgerwood, ND, with funds from the Road Department's "Equipment" line item in the 2017 Budget. Purchase price is \$9400 less trade-in of the JD 4020 with loader & mounted side mower of \$7700 for a net cost of \$1700. (Arth/Anderson) Roll Call Vote: Yes – Arth, Walstead & Anderson. No – Hosford & Jacobson. Motion carried.

Merrill Engquist, Road Supervisor, arrived at the meeting & reported on road projects. The graveling projects are close to being completed. The road department is also still working on County Road #12 in preparation for the application of "Base One." The new snow plow truck was delivered last week. Bituminous Paving is setting up a hot mix plant in Bernard Mahrer Construction's gravel pit, and will be doing paving work in the area, so the road department is planning to repair as many potholes and dip areas on the county roads as can be done while Bituminous Paving is in the area.

Mr. Engquist also brought a list of items to put up for sale: 2 1975 International Dump Trucks; 1 1964 Semi Tractor; 1 Rex Packer; & 1 1984 International Dump Truck with wing & 1 way plow. Motion to sell the above items, along with the 1997 Ford Pickup from the park board inventory, on sealed bids.
