The Sargent County Board of Commissioners met at 10:15 a.m., following the county park board meeting, with the following members present: Jerry Waswick, David Jacobson, Sherry Hosford, Mike Walstead, and Bill Anderson. Also present was Lyle Bopp, State's Attorney; Jayne Pfau, Assistant State's Attorney; Donna Eklund, county resident; Ken Forster, Fair Board Member; Tibby Hinderlie, The Sargent County Teller; and Pam Maloney, Sargent County Auditor.

Commissioner Jacobson gave an update on the planning commission's September 15th meeting. A public hearing for the purpose of discussing the proposed resolution of the Sargent County Planning Commission which updates Sargent County's Zoning Ordinance No. 1 Solid Waste and Incinerating Facilities and Comprehensive Plan has been set for Monday, October 3rd at 8:00 p.m. in the Commissioner's Room of the Sargent County Courthouse. The proposed resolution is available for inspection at the office of the Sargent County Auditor.

Motion to execute a Cooperative Agreement between Sargent County and the ND Game & Fish Department to upgrade & improve the public access road to Alkali Lake (Tewaukon WMA). The proposed agreement, prepared by the ND Game & Fish Department, had been reviewed by Assistant States Attorney Jayne Pfau, and, in her opinion, it was in proper form and was within the authority of the County Commission. (Anderson/Walstead, unanimous)

Motion to approve Application for Special Permit to Sell Alcoholic Beverages at Special Event at Designated Premises to The Black Pelican of Wyndmere, ND. The event will be October 15 in the Rutland City Hall, but as the Black Pelican's licensed premises is located outside of the county, the business needs both a city and a county permit. The owners of the existing licensed establishment in Rutland approved of the issuance of the special permit due to the unusual circumstances that existed at the time the Black Pelican agreed to provide the service. (Hosford/Jacobson, unanimous)

Motion to execute Contract for Services with the North Dakota Association of Counties (NDACo) to update Sargent County's Human Resource Manual. States Attorney Lyle Bopp had reviewed the proposed agreement that had been prepared by NDACo and, in his opinion, it was in proper form and was within the authority of the County Commission. (Anderson/Hosford, unanimous)

There was discussion on the Five Star Dairy conditional use permit that had been granted to the Dairy by Hall Township. There have been no fees paid pursuant to the terms of the conditional use permit since November 2014. The state's attorney's office will contact the township about a possible revocation of the conditional use permit. There was also discussion about billing the Dairy for dust control on County Road #14 as the Dairy is also required by the terms of the conditional use permit to provide dust control adjacent to residences & at intersections on the roads the Dairy utilizes.

Mr. Bopp reported that there has been no communication from ND Job Service regarding the Schwab unemployment compensation claim.

Ken Forster, Fair Board member, provided a financial statement and gave a report on the 2016 Sargent County Fair. He reported that attendance was very good, even in the extreme heat of that weekend. Finances also look good. Some improvements that had been made at the fairgrounds included: adding pens to the horse barn; installing drain tile to eliminate some boggy areas; replacing the large sliding doors on the cattle barn with an overhead door; &, preparing a motocross course. Improvements for the future include adding air conditioning capability to the auditorium. The Fair Board has upgraded the electrical system there to better handle an air conditioning system. The commissioners commended the Fair Board on a job well done, and they are looking forward to the Sargent County Fair 2017.

Merrill Engquist, Road Supervisor, arrived at the meeting. He reported that the Road Department pickup damaged in a deer collision last Spring has been repaired, but needs to be inspected and approved for highway use. Gravel projects are still in progress on County Roads #3 & #14. There was some discussion about trees in the right-of-way on County Road #14 that are obstructing the view of drivers. Mr. Engquist will check it out. Commissioner Hosford reported on the culvert on County Road #1 between Section 4 & Section 9 of Harlem Township that had been replaced by the County Water Resource Board in 2015. The culvert did not meet County Road Design standards in that it was too short, and therefore needed to be corrected. The current culvert will be salvaged and re-installed with an additional 32' center section added. Discussion on who is responsible to place the Stop sign for northbound traffic at the railroad track in Rutland City recommended by ND DOT subsequent to last Spring's inspection. Commissioner Anderson will contact Jim Styron of the ND DOT to obtain some guidance.

Authorize the County Auditor to request another permit from the ND Game and Fish Dept. authorizing the shooting or trapping of muskrats out of season to protect roadways experiencing road damage resulting from muskrats undermining roadbeds. (Jacobson/Anderson, unanimous)

Motion to authorize the custodian to purchase a Cyclone Rake XL for use with the courthouse mower for leaf & grass pickup. (Anderson/Hosford, unanimous)

More discussion on compensation for social service board members who have spent time working in an administrative capacity in the absence of a director. Motion to compensate the social service board members, on a per diem basis for additional work done in an administrative capacity, including budget preparation. (Anderson/Walstead, motion carried, Hosford abstained from voting)

Motion to appoint Vanessa Bayger as delegate to the State Fair Association's Annual meeting to be held in Minot on November 17, 2016 at 1:00 p.m. (Anderson/Walstead, unanimous)

Approve the purchase of a HP Color Laserjet Pro MFP printer for the auditor's office pursuant to proposal received from NRG Technology Services. (Anderson/Walstead, unanimous)

Approve minutes of the September 6, 2016, commission meeting as corrected. (Walstead/Hosford, unanimous)

Motion to increase the compensation for County canvassing board members to one and one-half (1½) times the state minimum wage or \$50 per meeting, whichever is greater. (Anderson/Hosford, unanimous) Members of the County Canvassing Board are also reimbursed for mileage, pursuant to State law.

Approve September payroll in the sum of \$184,392.13 (Nos. 12549-12617 and 73718-73731) and the following bills excepting one voucher for JDA funds: (Jacobson/Hosford, unanimous)
