Forman, North Dakota September 21, 2021

The Sargent County Board of Commissioners met at 9:15 a.m. with the following members present: Jason Arth, Lyle Bopp, Mark Breker, Richard Ruch and Jerry Waswick. Also present was Pam Maloney, Sargent County Auditor. Mary Engst, Sargent County Teller, was present through technology.

Chairman Lyle Bopp called the meeting to order.

The Pledge of Allegiance was recited.

Motion to approve the agenda as amended. (Breker/Arth) Motion carried unanimously.

Discussion was held on the Cellular Phone Reimbursement policy. The policy reads that \$50 is reimbursable for smart phones, however, there is an employee who only pays \$38.51 for his prepaid cell phone plan. Motion made to amend the cell phone policy to reimburse the actual cost of an employee's cell phone plan up to \$25 or \$50, depending on what reimbursement they qualify for. (Waswick/Arth) Roll Call Vote: Yes – Arth, Bopp, Breker & Waswick. No – Ruch. Motion carried.

Jill Mulder, Human Resources Director, arrived at the meeting at 9:30 a.m. Jayne Pfau, State's Attorney, arrived at the meeting at 9:37 a.m.

Motion to approve the September 7 & 13, 2021 minutes as presented. (Breker/Waswick) Motion carried unanimously.

Tim Faber, Road Supervisor; & Damon DeVillers, Interstate Engineering; arrived at the meeting. Discussion was held on the crack sealing that should have been done by Bargen prior to the chip seal project. Mr. DeVillers tried several times to contact Bargen regarding the timeline of the project, but was unsuccessful. The company did get three miles done of the project before the crew had to stop due to contracting the Covid virus. Motion to send a letter to Bargen, Inc, requesting to cancel Project 1 (County Road #4-Stirum-3 miles) & Project 2 (County Road #4 from #11 south to Brampton/County Road #5) as we have exceeded the funds allotted for crack sealing for the year with the considerable increase in costs of the completed Project 3 (County Road #10 from #11 north to gravel). (Waswick/ Arth) Upon roll call vote, motion carried unanimously.

Mr. DeVillers stated that he is having trouble getting quotes/estimates for the parking lot project. He will continue to contact contractors.

Discussion was held on County Road #4 north of Highway 13. The road is in terrible shape with several potholes and is a safety issue. Motion to hire Buck's Paving to fill the holes on County Road #4 north of Highway 13 at an approximate cost of \$30,000. (Waswick/Breker) Upon roll call vote, motion carried unanimously.

Mr. DeVillers also stated that bridge inspections are being done at this time & that the county needs to respond quickly to any needed repair work.

Brenda Peterson, Health Unit Administrator, joined the meeting through technology. She stated that there are 17 active Covid cases in the county as of today. She stated that two of the county schools are testing again, so that alleviates some of the burden of their department.

There has been a request from a county citizen for the Sheriff's Department to put decals on their patrol vehicles. As the sheriff is an elected position, the county commission cannot force this action, as he has the right to supervise his department as he deems fit. However, the county commission does control the sheriff's budget. No further decision was made.

## SARGENT COUNTY RESOLUTION FOR SARGENT COUNTY EMERGENCY MANAGEMENT

WHEREAS, the 49<sup>th</sup> Legislative Assembly passed the "North Dakota Disaster Act of 1985: (NDCC 37-17.1) enacting an emergency management law embodying all aspects of disaster/ emergency preparedness for all types of hazards which could seriously affect this county; and

WHEREAS, the law mandated the formation of local disaster organizations responsible to provide effective response and recovery capabilities to reduce the loss of life and property of our citizens from the effects of disaster or emergency; and

WHEREAS, the law provides that each county shall maintain an emergency management organization that serves the entire county, and each city shall provide an emergency management organization of its own, or it shall participate in the county wide emergency management organization; and

WHEREAS, the State Law requires the cities and counties to notify the North Dakota Department of Emergency Management of the manner in which their jurisdiction is securing an emergency management capability,

NOW, THEREFORE, BE IT RESOLVED, that the County of Sargent will be a participant in the Sargent County Emergency Management Agency.

Roll Call Vote: Yes - Arth, Bopp, Breker, Ruch and Waswick. No - None. Motion carried.

Discussion regarding the date for December's Five-County Meeting in Ransom County. December  $2^{nd}$  would be acceptable.

Commissioner Breker has contacted the State Game & Fish Department regarding whose responsibility it is to mow road ditches on game & fish lands. The gentleman he contacted will do some checking and let Commissioner Breker know.

The commissioners have all received correspondence regarding the proposed CO2 pipeline to capture CO2 from ethanol plants across the Midwest & transport & then inject the CO2 into the favorable geology of central/western ND.

Some discussion was held regarding the Sargent County Ambulance billings. Commissioner Waswick had received a phone call about some unpaid bills to the Oakes Ambulance Service and also a question about billing the intercepts at an increased ALS rate. The commissioners will visit with the coordinator at their next quarterly meeting.

A request was received for an employee to bring her dog to work. Motion to allow the pet to come into the workplace, pending the receipt of a signed Liability Waiver. (Arth/Waswick) Upon roll call vote, motion carried unanimously.

A meeting will be scheduled with the custodian to discuss his job duties & whether he has enough time to fulfill those duties in his workday.
