Ms. Seeyle stated that the Assistant Park Manager, Paul Serenko, would like to have 50 hours a week. It was explained to Ms. Seeyle that there can't be overtime. If any overtime should be needed, it must be preapproved.

Ms. Seeyle mentioned that she wants to go to full nine month pay and apply for unemployment in the winter. Ms. Seeyle's pay will be added to the next meeting agenda. Ms. Seeyle stated when she went to a 12 month payroll, she was allowed overtime.
