OLD BUSINESS: The pickup is at Willprecht's and they will install a new motor for \$450. Karen reported that she has ordered 4 toilet paper holders for \$29.64 and 3 cases of toilet paper from Stein's Chemical. Quentin and Ray B. met at Silver Lake on April 24 with the State Water Commission, NRCS, Water Board and the Red River Riparian Board. There will be a survey of the north side and the west side of the lake to stabilize the shoreline.

NEW BUSINESS: Jerry has the tractor running and has mowed. There is a problem on the eastside that needs bobcat or Payloader work to repair the ruts to the road.
