The Sargent County Park Board met at 8:03 a.m. in the Commissioner's Room at the Sargent County Courthouse with the following present: Jason Arth, Lyle Bopp, Mark Breker, James Peterson, Richard Ruch, Jerry Waswick & Julie Colemer. Also present: Sue Seelye, Park Manager; Mary Engst, Sargent County Teller; and Pam Maloney, Sargent County Auditor.

James Peterson, Chairman, called the meeting to order.

Motion to approve the minutes of June 15, 2021 meeting as presented. (Colemer/Bopp, unanimous)

The financial statement showed a balance of \$106,802.48 in the Park Fund, and \$2,510.42 in the Kraft Slough Project fund. Approve financial report (Waswick/Breker). Upon roll call vote, motion carried unanimously.

Shay Walden still has not started the bathhouse or shelter projects. Mr. Peterson talked with Mike Harris of Harris Concrete about taking over the project. It was decided to talk to Mr. Walden & tell him another contractor was willing to do the project as he doesn't seem to have the time for it.

Ms. Seelye reported that a few campers are dumping their grey water onto the ground. She had talked with them & all have stopped. Motion to add "No Grey Water Dumping on the Ground" to the camping rules and regulations. (Bopp/Arth) Upon roll call vote, motion carried unanimously.

Ms. Seelye also reported that there were a few seasonal sites that needed to be mowed. It was determined that courtesy calls were not necessary – if lots are not mowed, the park staff will mow them & the renter will be charged a \$50 fee, as the renter rules state.

It was brought to the board's attention that one of the seasonal site renters has guests staying on the lot. It was decided to send a letter to the renter stating they were in violation of the seasonal site renter rules and their lease would be terminated if they continue the practice.

There is some riprap with rebar in it that is a safety issue for the public. More research is needed before it can be removed.

Ms. Seelye stated that the lake has been tested for the blue algae fungus. There are some toxins, but not high enough levels to be a safety concern.

Motion to approve payment of the following bills: (Waswick/Bopp). Upon roll call vote, motion carried unanimously.
