The meeting was called to order with the following present: Dan Jacobson, Jim Bosse, Maynard Lien, John Totenhagen. Absent: Mike Paczkowski.

Craig Speich met with the Board to discuss a water problem in Section 17-132-53. The water does not leave his farmstead and is causing problems. He would like to lower the ditch in Section 16 to drain farmyard. Lucky Heuther granted permission to do this. The Board agreed with the request, if he gets floodage easements from the downstream landowners. Craig will talk to the landowners and get back to the Board.

Mike Paczkowski arrived at 1:55.

Approved minutes and financial statement. (Paczkowski/Bosse, unanimous)

Cash CD #31323 and purchase two (2) \$120,000 for 12 months. (Lien/Totenhagen, unanimous) Interest goes into Water Board General Fund.

Beaver dams did not get removed. Too much water now and will have to wait.

Gwinner City is proceeding with the storm sewer project which will flow north of Gwinner.

Summer Water Institute for Teachers - Board will sponsor one teacher from each school.

Jeff Volk, Moore Engineering, and about 25 landowners along Shortfoot Creek arrived at the meeting. Jeff reviewed the watershed area and explained the assessment area. He noted that more of the watershed area is located outside of Sargent County and this could cause problems. The total drop in the 10 mile area is 35 feet. He said the project must be identified on what work should be done and study the permit requirements. Several alternatives were discussed and estimates for a channel cleanout are \$60,000-\$80,000 or a deepening and widening project would cost approximately \$500,000.

Several concerns about additional water and the capacity in the Wild Rice River were expressed. The Board will continue checking into feasibility of a cleanout. No decision will be made without a vote of the people involved.

Harold Lawrence one foot dike along the west edge of field in SE1/4-25-130-53 was approved. (Paczkowski/Bosse, unanimous) NRCS determined there is no impact on any wetlands and the placement will cause the water to remain in the ditch as it was designed to do and keep water being pumped by a neighboring producer from causing crop damage to Mr. Lawrence.

Vernon Rubey, Robert Nelson, Jim Berndt and Stanley Smykowski are concerned about beaver problems in the Wild Rice River. Jeff Volk will inquire at the Corps in Bismarck on solution. Also discussed vegetation in the river.

Silver Lake road project - Jeff reviewed preliminary plans and will check with NDDOT on bid specifications.

Drain No. 11 - Received appeal from Mr. Carson on February 27, 1995. According to Mr. Breitling, Washington hasn't approved the appeal and he is waiting for more information. The Board instructed Jeff to survey the natural outlet of the Drain, prepare proposal and submit to the COE.

Dan reported that Rod & Allen Nelson would like to remove 5 posts along Nelson Dam, straighten the fence and expand their calf lot. They would rip/rap lot if it washes out. Approved. (Totenhagen/Paczkowski, unanimous)

Chuck Anderson, Weber Township, asked permission to put a dike back in by his farm and clean the township road ditch. It doesn't affect anyone but him. Permission granted.

Milnor Township culvert request - send a letter to all township supervisors instructing them that this Board will not consider any future requests until the 1994 recommendation is completed.

The meeting was called to order with the following present: Dan Jacobson, Jim Bosse, John Totenhagen, Maynard Lien, Mike Paczkowski, Charles Anderson, Brad Smith, Jerry Woytassek, (members of the Weber Township Board), Murdean Gulsvig, Orvis Silseth, and Jeff Volk.

Jeff Volk, Moore Engineering, Inc. presented the Silver Lake Road Improvement map and reviewed the project. The curve will be moved about 100' south the east/west road about 15' south. Design standards for the curve require a 30 mph speed zone. They propose to pull some dirt off hill to rebuild. Apply for 404. The road will be raised 2' by slough and %'-3' on curve and lower in between. The roadtop will be standard 24'. Discussed amount of gravel as per township specs. Weber Township Board members accept the project and would like to coordinate gravel with contractor. They agreed to furnish road signs and continue maintaining road after construction.

Orvis Silseth approves the project and would like a culvert from the lake to the slough to allow him to irrigate out of the slough versus the lake. Will install a 3' culvert in the roadway. The fence on his property will be removed during construction and he would like it replaced afterwards. The Board will prepare floodage and right-of-way easements for Orvis to sign. Jeff will prepare the land descriptions.

Approved placement of a 24" culvert between Sections 1/12 in Whitestone Hil Township. (Totenhagen/Bosse, unanimous)

Jeff agreed to look at the two bridges in Tewaukon Township and prepare culvert sizing for replacement.

Directed Secretary to send a letter to Don Kiefer informing him that the county commissioners and this Board jointly agreed to remove the restrictor because the water is jeopardizing the road.

Maynard reported a group is Milnor City is interested in buying some of the right-of-way along old Drain # 7. Jeff reviewed and suggested the group do a survey and recommended that the Board retain 50' on southside of the centerline of the drain. Maynard took maps for the group to review.

Lowell Olson arrived at the meeting to review the Silver Lake project. His land is located in the NW1/4-4 and NE1/4-5. He asked how many acres are involved. He questioned what good is will do to raise the dam and asked about re-routing the creek. He probably would give the Board an easement after he finds out how many acres. Approved minutes and financial statement. (Lien/Bosse, unanimous)

Donald Colby requested permission to install a 24" culvert in Willey Township between Sections 33 & 34 and a 36" between Section 4 of Dunbar Township and Section 33 of Willey Township. Approve. (Bosse/Paczkowski, unanimous) The 36" culvert was approved and funded through FEMA monies due to the flooding last spring.

Mr. Colby informed the Board that the Yagow drain uprights are laying down and excess water is a problem. The Board agreed to send a letter to both Alvin & Myron Yagow instructing them to place the uprights in a vertical position immediately.

Fred Geise, Murdean Gulsvig and Quentin Hoistad arrived at the meeting. The Board reviewed a map from State Water Commission showing acreage needed for Silver Lake project either through purchase or floodage easement. Fish and Wildlife acreage in the W1/2-SE1/4-33-130-55 includes 39.0 acres flood easement and 17.1 acres for purchase. Mr. Geise is not concerned with raising the lake, but wants assurance for low flow years. He informed the Board that the paper work should go to the Denver Office and they would refer to him for his recommendations. He suggested preparing a draft easement and a hand sketch of the anticipated structure in the lake. They would review, make any amendments and return to this Board for final consideration.

Mr. Geise discussed the water problem in Whitestone Hill Township by the cemetery. He has offered the use of his pump to remove the water. The township wants to dig a ditch and he cannot allow that because of wetland easements.

Jim Berndt, Louie Gaukler, Robert Nelson and Ed Gaukler met with the Board and presented a petition with 135 names of farmers and ranchers along the Wild Rice River. They urge this Board to stop any plans for enlargement of the water district and not to clean out or do any dredging or trenching of Shortfoot Creek between Sargent County Drain # 3 and where it dumps into the Wild Rice River in Section 31-131-53. They feel something has to be done with the river before any more water can flow into it.

Phillip Freeman, Roy Vig, Bennie Jensvold and Duayne Baldwin, Marboe Township asked permission to replace 2-24" culverts with a 36" between Section 14 & 23. Approved placement and cost share. (Totenhagen/Lien, unanimous) Talked about cleaning the road ditch in this area to keep the water in the ditch.

Several landowners living along Drain # 3 arrived at the meeting requesting the Board clean out the drain. It has been several years and the silt is built up and causing problems. The Board felt it must be surveyed before cleaning and will contact Moore Engineering to conduct the survey. Authorize Mike Paczkowski to work with Moore Eng. in completing the survey. (Lien/Bosse, unanimous)

Jim Bosse talked to Bill Huffman on draining a slough. He does not think it is over 80 acres and does not involve ACSC or SCS payments or Swampbuster.

Letter to D. Donley Hom on Silver Lake project returned 4-14-95 unclaimed. Secretary instructed to send again to the Sioux Falls address by certified mail.

Jeff Volk faxed information on the bridge in Tewaukon Township. He recommends comparing prices for repair versus replacement and provides culvert sizes for replacement. The county commissioners will be contacted about repairs.

Drain No. 11 transcript is being prepared for the government. They will have several months to review and decide what they want to do.

Howard Huffman culvert ordered is 30" x 42'. Township will install the culvert and this Board will pay for the culvert.

Approved cost share of a 36" \times 36 foot culvert between Rutland and Weber Township - Section 31. (Lien/Totenhagen, unanimous)

Milnor Township requested cost share to replace a 48" x 44 foot culvert between Sections 34/35. Approved contingent upon receipt of the culvert map for their township. (Totenhagen/Paczkowski, unanimous)

Reviewed list of teachers and students attending the WET summer classes. Bobbi Thompkins, Milnor is registered. Board agreed to pay fee of \$225.

Harvey Bergstrom asked for cost sharing to install a culvert in his field. No monies available for this type of project.

The meeting was called to order with the following present: Dan Jacobson, Jim Bosse, Maynard Lien, Mike Paczkowski, John Totenhagen. Absent: None. Also present: Jeff Volk.

Prior to start of meeting, those present toured the water problem in the City of Forman.

Approved minutes and financial statement. (Paczkowski/Lien, unanimous)

Instructed Secretary to reinvest CD # 31397 on 5/30/95 for 12 months. (Lien/Bosse, unanimous)

Ray Nelson (NW1/4-5-131-58 arrived at the meeting to discuss a water problem. The railroad acts as a dike and cuts off 39 acres of his land and does not move anywhere. This is a natural drain and would need about 60 rods cleaned. The Board instructed Mr. Nelson to talk to SCS and the adjacent landowner. The natural drain maintenance is the responsibility of the landowner.

Jeff updated the Board on Drain No. 3 indicating that some of the area has been surveyed, but not tied together. The Board requested that he survey the entire drain and tie the other areas together to determine the level of grade. Could possibly clean Section 28, 29 and up to 2/35 with the current levy balance and two additional years assessment.

Drain No. 11 survey and the outlet in Taylor. The Board asked Jeff to start at the SW1/4 of Section 1-11-10/13. There is a blockage somewhere in that area. He will complete a profile and compare the data to the 1969 Bureau of Reclamation survey.

Jeff agreed to prepare the easements on the Silver Lake Dam for review by the U.S. Fish and Wildlife Service. Briefly discussed the Silver Lake road project.

Bill Huffman asked permission to drain an area between Sections 27/34 in Harlem Township. He was told he would be in violation but he is not in the farm program. It appears to be more than an 80 acre drainage basin and therefore needs a permit. He was instructed to prepare the permit and submit to the State Water Commission.

Dale Asche asked to clean the county road ditch to re-route water along County No. 1 between Section 14 & 23, Dunbar Township. The water will end up in the same area, but would necessitate removing 2-21/2 feet of dirt and lowering culverts. This would also require a permit. He will prepare with the adjacent landowner and send to the SWC.

Bridge between Section 21/22, Tewaukon Township - county road department will make repairs instead of replacing.

Maynard reported the uprights are in a vertical position on the Yagow land.

Larry Tangen looked at beaver problem but it is to wet to start any control.

Granted permission to Sargent County to lower a slough located in Section 18 of Shuman Township. (Bosse/Paczkowski, unanimous)

Approve cost share of $36" \times 40"$ culvert for Rutland Township to replace existing culvert located between Section 2/3. (Lien/Totenhagen, unanimous)

Received a complaint from Elroy Enervold on a drain in SW1/4-19, Whitestone Hill Township. Approximately 40 acres has been drained since 1968 and is causing flooding to a township road in Vivian Township. Instructed secretary to contact Vivian Township Clerk for information on original construction.

Approved placement of an approach in Section 16-130-54 with an 18" culvert. (Totenhagen/Bosse, unanimous)

Rex Ferguson appeared on behalf of Cogswell City regarding the continuing water problem. The old tile drain (#16) isn't working and the water is backing up into Cogswell causing flooding to the lift station and streets. State Hwy # 11 needs an opening because the existing tile is plugged and does not allow the water to flow. The Board declared an emergency and will contact the NDDOT to request immediate excavation of the highway.

Forman City is also experiencing water problems on the west side of town.

Water is flooding a trailer court, damaging homes, utility company property, and creating a hazard for the citizens of Forman. Legal Drain # 4 on the east side of Forman is the outlet for this water which would require burying pipe through town, excavating under State Hwy # 32, more underground pipe until it reaches the drain. At this point the ditch could be open cut and the water would flow easterly until it reaches Crooked Creek.

Maynard Lien introduced the following resolution and moved its adoption:

WHEREAS, the Sargent County Commission declared a State of Emergency in the County on May 10, 1995, and

WHEREAS, due to excessive rainfall in the Spring of 1995, the flooding problems of 1993 & 1994 have added additional strain to the 199 spring flooding conditions and overflow of creeks, sloughs and drains, and

WHEREAS, the County has suffered damages to roads, culverts, agricultur land, homes utility company property and mental strain on the officials and residents of the County, and

WHEREAS, the City of Cogswell and the City of Forman are in a state of emergency to protect their city water systems, lift stations and public safety of their citizens,

NOW THEREFORE BE IT RESOLVED, the Sargent County Water Resource Board declare an emergency exists and the areas of the Lateral to Drain No. 11 and Forman Drain No. 4 require immediate attention and excavation of State Highways to allow the water to more from the cities,

BE IT FURTHER RESOLVED, the Water Resource Board contact the North Dakota
Department of Transportation, State Water Commission and ND State
Health Department to advise of the problem and that we are
proceeding with necessary work and ask for any financial assistance
that is available.

Dated at Forman, North Dakota is 18th day of May, 1995.

The meeting was called to order with the following present: Dan Jacobson, Jim Bosse, John Totenhagen, Maynard Lien, Mike Paczkowski and Jeff Volk. Also present: Donald A. Nelson and Eugene Miller

Discussed cleaning Forman Drain No. 4. Work began on 5-31-95 at the section line and went out around the lagoon. The city will install 24" pipe through town and the Water Board will replace pipe in the area by the lagoon. Asked permission of Mr. Nelson and Mr. Miller to clean through their property in the SE1/4-32-131-55 and NW1/4-5-130-55. Dirt from the original construction wasn't leveled and will be with this project. This Board doesn't have easement on said property and both landowners were agreeable to proceed with the project. The Board asked that if they see something that does not satisfy them that they get in touch with a Board member. Discussed a culvert replaced by Fish and Wildlife that is possibly 2 feet too high. Dan will talk to them about lowering it.

Edwin Erickson has excess water in his yard from Buffalo Lake. County commissioners and Water Board members inspected the area and Mr. Erickson asked for a larger culvert in the county road between Section 7/18 of Shuman Township. After reviewing the culvert map and sizes of existing pipe, agreed to approve adding a 36" culvert. Mr. Erickson should work with SCS to coordinate the grades and stay in compliance with Food Security Act and avoid any wetland violation. (Lien/Totenhagen, unanimous) The county will have to work with Erickson on cleaning the ditch because it is a county road.

Dennis Brezicka contacted Dan about replacing some culverts on the Dunbar/Rutland Township line. Between Section 32/5 a 30" would be replaced with a 30" and between 33/4 3-36" culverts replaced with 3-48" culverts. These culverts are in bad shape and need replacing before the cleaning of Drain No. 4. Approved 1/3 cost share. (Bosse/Paczkowski, unanimous)

The Elroy Enervold complaint filed in May was discussed. It appears the drainage is less than 80 acres and did not require a permit. The Water Board has no jurisdiction over this matter. (Paczkowski/Bosse, unanimous) A reply will be sent to Mr. Enervold.

Sandy Hanson met briefly with the Board and updated them on FEMA and the disaster declaration. June 2nd is the deadline and she will submit information relative to Forman City and Cogswell City flooding and hopefully they will include Sargent County in the declaration.

Discussed cleaning the outlet to Drain No. 11. Jim talked to the COE and they approved an application to cleanout the natural outlet which consists of removing cattails from the channel of the Wild Rice River beginning in the northwest corner of the NW1/4-8-129-56 and following the river through Section 9,10,11, and 2 and ending in the NW1/4-1-129-56. (Application No. 199560694) Jim talked to the Hutterites and they can begin work next week. A letter was composed and will be sent to all affected landowners along the river informing them of the project and reason for the cleanout. After this work is completed, the work will begin on SC Drain No. 16. A meeting will be scheduled to meet with all landowners along Dr # 16 to discuss this project and the pros and cons of open ditch versus tile drain.

The meeting was called to order with the following present: Dan Jacobson, Mike Paczkowski, Maynard Lien and John Totenhagen. Absent: Jim Bosse. Also present: Jeff Volk, Sandy Hanson, David & LeAnn Even, Bonnie Gisi, Jim Kunkle, J.D. Bopp, Ted & Paul Mathews, Larry Albertson, Rex Ferguson, Harlan Klefstad, William & John Hayen, Todd Stein, and Kenneth, Lillian & Kent Lamb.

The purpose of the meeting was to meet with landowners along the old tile drain # 16 in Sargent Township. The Water Board acquired right-of-way deeds for construction and maintenance of a tile drain in the early 1900's. Excessive water in the City of Cogswell is unable to drain because the tile does not work properly.

Jeff explained the scenario of Cogswell and various options: 1)locate tile and see if water is flowing or 2)remove tile and leave open channel to relieve water in Cogswell. Drain No. 11, the outlet to this tile drain, needs work on the outlet in Taylor Township to improve the flow of water. This work is being done now and U.S. Fish and Wildlife have contacted the Board regarding this project.

Andy Wingsbach, DC from SC NRCS addressed a letter to the Board with these concerns: 1) Open ditch-remove old tile and replace with drainage ditch(not recommended), 2) New tile-remove old tile and replace with new tile(expensive) and 3)Open ditch\tile-open ditch in non-wetland area's with tile (new or old) in wetland area's, not to lower existing wetland boundaries (workable and not as expensive). A minimal effect exemption can be granted only after this Board agrees to sign a minimal effect agreement. This also would have to be signed by NRCS and FWS.

New ideas, alternatives and discussion followed by those in attendance. The majority felt the project should proceed to reduce the problem in Cogswell. Discussed rerouting water west of Cogswell. There is a 25' incline from the northeast corner of Cogswell to the cemetery and the water would not flow unless a 20-30' cut were made. Difficult to pump lift station over the hill. There is not an estimate available at this time for this suggestion.

Jeff reviewed the original assessment list and percentages assessed to adjacent land including the City of Cogswell lots and blocks. He will do some figuring on this list to determine benefit of assessment.

The concerns from SCS must be addressed and those present are willing to meet again to express how this water is affecting them. The lift station is sandbagged and they are pumping steady. The manholes are covered with plastic and sandbagged.

After landowners left the meeting, the Board continued to discuss options and what process would be most practicable for this area. They will keep working on the Presidential Disaster Declaration and Dan will talk to SCS prior to the regular meeting tomorrow night.

Approved minutes as amended and financial statement. (Lien/Totenhagen, unanimous)

Chuck Anderson and Brad Smith, Weber Township Supervisors, met with the Board to discuss water problems between Section 10/11 and 3/11 by Darren Hoistad's. They would like rock crossings and asked for assistance. The Water Board will inspect next week and talk to the commissioners about cost share. Requested cost share on a 36" x 36' culvert to replace existing old culvert between Section 13/24. Approved. Chuck Anderson also discussed a problem by the bridge in the SE1/4-14 which has washed topsoil into the creek. This is a natural waterway and landowner responsibility. He will work with the township.

Donald Marquette, Colin Stockstad, Elvoy Askerooth, Elwood Enge, Eugene Johnson, John Lunneborg and Mervin Wohler arrived at the meeting seeking information on the water problem in Forman and the effect it will have on the downstream landowners. Dan described the problem with Dr. # 4 and showed pictures of the water around Forman. The pipe installation (5100 feet) is nearly completed and cleanout on the east end soon finished. A gate will be placed on the east end to control water. Estimate 600 acre feet of water will flow through the drain. The landowners are concerned about the water and the quality (lagoon contents). Dan said Forman City received permission to dump as the water passed the state specs. Colin Stockstad asked about keeping more water in Buffalo Lake all the time and what can be done to do this. The road on the south side must be raised to keep from flowing to the south. Other concerns about the east end of Crooked Creek and flowing into the river. Some natural waterways should be cleaned and elevations on several culverts checked to be sure the water can flow to the east. The

lver Lake permit - may have to reapply for another permit. Problems with rst permit and how the 12.3 acres feet of water was included in the permit plication. Should hear from SWC after the hearing date closes today.

Jim updated the Board on cleaning the outlet to Dr #11. Work started about 1 week ago and is progressing nicely. The water has dropped 32" and Jim is taking measurements at different locations to compare with original depth's.

Discussed spraying legal drains and will contact a helicopter to do Dr. # 11.

Cogswell water problem-Drain No. 16 - Jeff agreed to meet with NRCS to discuss options and get agreement ready to begin work on the tile.

Entered into an agreement with USDA Animal and Plant Health Inspection Service Animal Damage Control Division to cooperate in a wildlife damage management program to reduce agricultural losses caused by beaver within the county. Scott Johnson, representing Ransom-Sargent Rural Water asked the Board if there is funding available for a feasibility study. They have received \$130,000 MRI funding through GDCD and need an additional \$70,000. He reviewed maps of the system and said they would not begin until 1997. The Board requested copies of the map to see how many Sargent County residents are involved in the system.

John & Bill Hayen and Kent Lamb informed the Board they had been pumping an area of Drain # 16 and they got down to the top of the tile. They will contact the NRCS on Monday and invite them to visit the site to view what is happening.

Approved minutes as written and financial statement. (Totenhagen/Lien unanimous)

Authorize Secretary to cash CD #32301 and deposit in General Fund (Lien/Totenhagen, unanimous)

Received a copy of the Annual Dam inspection report. No problems seen on any of the channels, however, Wild Rice # 1 & # 9 have some small willow trees that had been sprayed last year and are now dead. All channels had areas of thick cattail growth. Brummond/Lubke Dam needs repair on all 4 wires on the fence. Cattle have started to form a trail on the south end and should be re-routed to stop possibility of gully farming. Frenier Dam needs repair on fence on the west end and only minimal amounts of leafy spurge. Nelson Dam had no problems and grass looks excellent.

Forman Drain No. 4 - work is complete and water has drained remarkably fast from the city. Some flooding occurred on Gene Miller land due to WPA not being cleaned. Still some problems with culverts on Old # 11. FEMA inspected the project and submitted a damage survey report to the federal office.

Outlet to Drain # 11 - work is complete and working good. A few more areas should be checked for cattails and cleaned if necessary.

Edwin Erickson water problem - approved 30" between Sections 7/18 and remove 24" and also replace 2 30" between Sections 8/9 with 1 30". Approve paying one-half of the total culvert cost. (Bosse/Paczkowski, unanimous)

Drain No. 16 - scheduled a meeting for July 24th to meet with the Mathews family, Duane Breitling and Jeff Volk to discuss various options on the tile drain.

Drain No. 11 - the 8th U.S. Circuit Court of Appeals dismissed the government's appeal in accordance with Federal Rules of Appellate Procedure 42(b). Dan will make arrangements to pick up and return all records and historical data from the Ohnstad Law Office.

The purpose of the meeting was to meet with the Mathews family to discuss various options to resolve the problem with Drain # 16.

Jeff explained the two options: 1) replace tile that is not working or 2) start at the outlet and remove tile and leave an open ditch. Landowners to the north are in favor of an open ditch and this would be more economical. The wetland issues are close to being resolved, although no wetland issue are present in Section 23.

Paul Mathews stated that the open ditch on Section 23 does not follow the tile and that the outlet is at a different location. They are not in favor of a new open ditch. The Board could replace the tile in 23 at the original design and preclude the Mathews from farming over the top because of the depth. What is the Mathews preference? They are concerned about flooding and who will reimburse them for damages.

Mr. Mathews read the concerns in a letter dated June 16, 1995 from John Cichy, Attorney and asked why they had not received a reply. Mr. Breitling indicated they are not issues until they happen.

Dan stated that Mathews did not have a drain application or permission to remove the tile. They dug a new open drain and never contacted the Water Board for assistance. The Board either has to get the tile open, install new tile or dig a ditch.

Mathews asked why the water can't be pumped west or if a holding pond could be dug. He also stated that the Board could buy their land.

The Water Board asked Jerry Bohnenkamp to check the tile to see where it is working. John Hayen and Kent Lamb did some pumping to check if it is flowing.

Mathews said they will have to think about it and left the meeting.

The Board discussed what their options are and agreed that an emergency exists and offered the following resolution: (Bosse/Paczkowski, unanimous)

WHEREAS, due to excessive rainfall in 1995 and flooding problems in 1993 & 1994, additional strain has occurred in creeks, sloughs and drains, and WHEREAS, the City of Cogswell is in a state of emergency to protect their city water system, lift stations and public safety of their citizens, NOW THEREFORE BE IT RESOLVED, the Sargent County Water Resource Board declare an emergency exists in the area of old tile Drain # 16 and immediate attention and excavation is necessary to alleviate the water problem in th City of Cogswell,

BE IT FURTHER RESOLVED, the Board is authorized to negotiate with contractor

Jeff will negotiate prices on pipe and contact contractors. Jim will talk to local contractors and get ready to proceed with necessary work. Duane says a temporary 404 permit is not necessary. This is clearly exempt and we will tile through wetlands if we have to. We can use perforated tile through Section 23 and in slough areas to the north. No minimal affect needed. The Board can dig an open ditch and replace with tile in a reasonable fashion.

Milnor Township culvert problem between Sections 3/4 and 9/10. Mr. Breitling will send a letter to the Board instructing them to install a 24" culvert within 30 days or the Board will do the work and place a lien against their taxes. (Bosse/Paczkowski, unanimous)

Approved minutes of July 20, 24 and August 9, 1995 meetings and financial statement. (Paczkowski/Lien, unanimous)

John Lien, Milnor Township, met with the Board to discuss the culvert problem between Section 3 & 4 of said township. The Board informed Mr. Lien that the township has until August 26th to install a 24 inch culvert or the Board will order the work done and place a lien against any and all tax collections of Milnor Township for reimbursement of the costs incurred in doing so. Maynard will keep abreast of the project and order the culvert if necessary.

David & LeAnn Even asked for an update on the Cogswell Dr # 16 tile. The Board met with FEMA several times and were told they would rent irrigation pipe and rent a pump to remove the water from Cogswell. It would take 90-120 days to drain. The Board is not happy with this solution and plan to appeal the decision once the paper work has been received by Sargent County. The Board encouraged the City of Cogswell to contact area legislators and state congressmen to explain the problem and seek financial assistance because the city is actually the sponsor of the project. For the present time, the Board will wait for papers from FEMA.

Bill Hayen and Rex Ferguson arrived at the meeting interested in the Cogswell water problem and discussed the south mile where pipe is being installed. They would like to see some additional inspection on the rest of the tile to see if portions are working and may need only minor repairs. RSR agreed to come out and check an area in Section 14 where they installed cable to see if they did any damage.

Glen Thompson is experiencing a water problem in Section 28-130-57 and requested the township to install an 18" culvert across the road between Sections 28 & 27-130-57 to allow the water to flow to Drain No. 11. Permission granted if no problem with NRCS or other landowners.

Silver Lake road project - Jeff contacted Crandall Construction with a proposal. No response at this time.

Prepared maps for helicopter spraying on Drain No. 11, 9 and SC Water Channel Imp. Dist. # 1. Dakota Helicopter Service, Beulah, ND will do the spraying the end of this month at a cost of approximately \$100/mile.

Jack & Boyd Brummond will make repairs to the fence as per dam inspection and Mike will check Frenier dam fence and look for leafy spurge.

Approved 30" culvert between Sections 21/22 of Tewaukon Township to replace 24". This is on county road right-of-way. (Paczkowski/Totenhagen, unanimous)

Discussed various legal drains and the need to place special assessments for 1995. Approve amounts as follows: Drain # 1 -\$.25; Drain # 2 - \$.25 Drain # 3 -\$1.00; Drain # 9 -\$.50; Drain # 11 -\$1.00; Drain # 12 - \$.75. These amounts are assessed per acre on the highest benefit apportioned. (Paczkowski/Totenhagen, unanimous)

The Board next proceeded to discuss the reassessment of Sargent County Drain No. 4. Commissioner Bosse introduced the following resolution and moved its adoption.
